Summary of Legislation

This bill, *recommended by the Economic Opportunity Poverty Reduction Task Force*, creates an adult education and literacy grant program in the Adult Education Office at the Colorado Department of Education (CDE). The State Board of Education (SBE) must adopt rules for the new program.

The grant program will provide state funding for adult education and literacy programs that participate in workforce development partnerships. Adult education and literacy programs provide eligible adults with basic education in literacy and numeracy, leading to additional skill acquisition, a post-secondary credential, and/or employment. A local education provider that operates an adult education program may apply to the CDE for a grant. Such providers include public and private schools, institutions of higher education, nonprofit community-based organizations, and other related agencies and consortia.

Grant recipients are required to provide specified information to the CDE, and the department is required to annually review the information and evaluate the effectiveness of grant awards. The department must prepare and submit an annual report to the governor's office, the SBE, and the Joint Budget Committee, education committees, and business committees of the General Assembly. The report must also be posted on the department's web site.

The CDE must convene periodic meetings of representatives from the Department of Higher Education, the Department of Labor and Employment, the community college system, other local education providers, and workforce development providers.

The bill creates the Adult Education and Literacy Grant Fund (fund) subject to annual appropriation by the General Assembly. For FY 2014-15, the bill appropriates \$1.2 million General Fund and transfers the remaining balance of the Family Literacy Education Fund, which is repealed by this bill. The fund may also receive public and private donations. The CDE may expend up to \$250,000 annually to administer the program, collaborate with state agencies and other partners, and evaluate grant recipients.

State Revenue

The bill permits the department to accept and expend donations or grants of any kind from public or private sources to credit to the fund; however, no amount of donations has been identified for this fiscal note.

State transfers. The bill repeals the Family Literacy Education Fund and transfers the remaining balance of \$1,104 to the Adult Education and Literacy Grant Fund on July 1, 2014.

State Expenditures

This bill increases state expenditures by \$1.2 million and 1.0 FTE in both FY 2014-15 and FY 2015-16. Increased costs are for program administration and operational expenses, and for grant awards to adult education programs. Total costs are detailed below and displayed in Table 1.

Program administration. The bill creates a new grant program at the CDE. The department will establish program rules, create application procedures, convene meetings of state agencies and community organizations, award grants, track and evaluate grant recipients, and assure accountability. Program staff will also provide outreach, technical assistance, and training, requiring statewide travel. Finally, the department will expend internal resources in information technology, human resources, accounting, budgeting, and management in support of the new program. The CDE requires the addition of 1.0 FTE Senior Consultant and associated costs to support the program.

Adult education literacy grants. It is anticipated that the program will award ten grants annually, each for \$100,000, with continued funding dependent on available appropriations. The grant amount is based on the department's experience administering similar federal grant programs for adult education, with a goal of serving more students and providing additional services. The goal of ten grant recipients is based on the current number of adult education programs receiving federal funds, and a projection of the number of programs that are likely to apply.

Third party evaluation and reporting. The CDE will contract a third party evaluator to assist with data collection, program evaluation, and reporting. The contractor will also provide guidance identifying and incorporating best practices in existing literacy programs. The department will select an evaluator through a competitive request for proposals (RFP). Based on experience with other federal grant projects, the professional third-party evaluator is estimated at \$75,000 annually.

Centrally appropriated costs. Pursuant to a Joint Budget Committee policy, certain costs associated with this bill are addressed through the annual budget process and centrally appropriated in the Long Bill or supplemental appropriations bills, rather than in this bill. The centrally appropriated costs subject to this policy are estimated in the fiscal note for informational purposes and summarized in Table 2.

School District and Higher Education Impact

School districts and state supported institutions of higher education who partner with workforce development agencies to provide adult education and literacy programs are eligible to receive grants, increasing revenue for those schools, districts, or colleges that participate in the program.

Pursuant to Section 22-32-143, C.R.S., school districts and Boards of Cooperative Educational Services (BOCES) may submit estimates of fiscal impacts within seven days of a bill's introduction. As of the date of this fiscal note, no summaries of fiscal impacts were submitted by districts or BOCES for this bill. State Appropriations

For FY 2014-15, the bill appropriates \$1,200,000 General Fund and 1.0 FTE to the Adult Education and Literacy Grant Fund for implementation of the bill by the Colorado Department of Education.
