A BILL FOR AN ACT

101 **CONCERNING THE MANAGEMENT OF WASTE TIRES.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at <http://www.leg.state.co.us/billsummaries>.)

The bill repeals and reenacts the state's waste tire laws, consolidating the laws in a new part of the solid waste statutes and all regulatory authority in the department of public health and environment. The department's existing solid waste enforcement authority applies to waste tires.

The solid and hazardous waste commission will set the waste tire fee by rule in an amount not to exceed the current \$1.50 fee. In addition

to the existing application of the fee to automobile tires, the fee will also be collected on trailer, truck, motor home, and motorcycle tires. On and after January 1, 2018, the fee is set at 55 cents per tire.

Until December 31, 2017, the fee will be distributed as follows: 30% to the waste tire administration, enforcement, and cleanup fund; 65% to the end users fund; and 5% to the waste tire market development fund. On January 1, 2018, the entire fee is credited to the waste tire administration, enforcement, and cleanup fund, and the end users fund and the waste tire market development fund are repealed.

The commission will set the amount of the rebate payable from the end users fund, not to exceed \$80 per ton in an amount that is: The same each month for each successive 12-month period; based on the monthly rolling average weight of waste tires submitted for a rebate during the previous 36-month period; and calculated to equalize, but not exceed, the amount of rebates paid with the anticipated income to the end users fund during each succeeding 12-month period. The department must pay rebates on a per-ton basis, and the commission's rules governing administration of the rebate must specify that:

- ! If the weight of waste tires submitted for a rebate in any one month multiplied by the amount of the rebate exceeds the balance of the end users fund, the department will pay a reduced per-ton rebate that month; and
- ! The department must quarterly notify end users of the date on which the balance of the end users fund is anticipated to be insufficient to pay all of the rebates applied for.

Rebates can be made to end users, retailers who sell tire-derived product, and processors of Colorado waste tires who sell their tire-derived product to out-of-state end users. To avoid double payment of the rebate, once the department has paid a rebate on a particular quantity of tire-derived product, every part of that particular quantity of tire-derived product is no longer eligible for payment of the rebate.

Waste tire haulers cannot have more than 1,000 waste tires on site or store a waste tire for more than 3 days. Waste tire generators cannot have more than 1,500 waste tires at any one time and must develop and maintain written criteria for distinguishing waste tires from used tires, clearly identify waste tires and used tires according to the criteria, and organize used tires for sale in a manner that allows the inspection of each individual tire. Waste tire collection facilities cannot have on site more than 7,500 waste tires at any one time. Waste tire processors cannot have on site at any one time more than the lesser of 100,000 waste tires, the amount of waste tires allowed under local requirements, or the amount of waste tires anticipated in the waste tire processor's financial assurance instrument. Mobile processors of waste tires must register with the department.

Used tire sellers must distinguish waste tires from used tires,

distinguish used tires being held for sale in Colorado from used tires being held for sale outside Colorado, and organize used tires for sale in a manner that allows the inspection of each individual tire.

Waste tire monofills must:

- ! On an annual basis, for every one waste tire received, end use at least 2 waste tires, process at least 2 waste tires into tire-derived product; and
- ! Not place any waste tires into monofill storage after January 1, 2018, and close the waste tire monofill by July 1, 2024.

The waste tire advisory committee is repealed.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **add** part 14 to article
3 20 of title 30 as follows:

5 STRATEGIES FOR WASTE TIRES

6 **30-20-1401. Legislative declaration - rules - enforcement -**
7 **recyclable material.** (1) THE GENERAL ASSEMBLY HEREBY FINDS AND
8 DECLARES THAT, IN ORDER TO PROTECT THE ENVIRONMENT AND THE
9 PUBLIC HEALTH, THERE IS A SPECIAL NEED TO ADDRESS PROBLEMS
10 CREATED BY THE DISPOSAL OF WASTE TIRES AND THE LACK OF RECYCLING
11 AND BENEFICIAL USE OF WASTE TIRES. IT IS THE POLICY OF THIS STATE TO
12 PURSUE PROPOSALS FOR RECYCLING AND OTHER BENEFICIAL USE OF WASTE
13 TIRES IN LIEU OF STORAGE OR LANDFILL DISPOSAL, AND, IN ADDITION, IT
14 IS THE INTENT OF THE GENERAL ASSEMBLY IN ADOPTING THIS PART 14 TO
15 ENCOURAGE THE DEVELOPMENT OF TECHNIQUES FOR RESOURCE
16 RECOVERY, RECYCLING, AND REUSE OF WASTE TIRES AND TO PROVIDE FOR
17 THE MANAGEMENT OF WASTE TIRES.

18 (2) BY MAY 31, 2015, THE COMMISSION SHALL PROMULGATE
19 RULES FOR THE IMPLEMENTATION AND ENFORCEMENT OF THIS PART 14.

1 UNTIL THE COMMISSION PROMULGATES RULES TO IMPLEMENT AND
2 ENFORCE THIS PART 14, THE COMMISSION'S RULES IN EFFECT ON JULY 1,
3 2014, GOVERNING WASTE TIRES CONTINUE TO APPLY TO THE EXTENT THAT
4 THEY DO NOT CONFLICT WITH THIS PART 14.

5 (3) THE DEPARTMENT SHALL ENFORCE THIS PART 14 THROUGH ITS
6 ENFORCEMENT AUTHORITIES, INCLUDING THOSE SPECIFIED IN SECTIONS
7 30-20-113 AND 30-20-114.

8 (4) AFTER TIRES ARE USED FOR THEIR ORIGINAL INTENDED
9 PURPOSE, THEY MUST BE USED BENEFICIALLY, RECYCLED, OR REUSED;
10 EXCEPT THAT, IF AUTHORIZED BY SECTION 30-20-1414 (1) (b), THEY MAY
11 BE DISPOSED OF AT A PERMITTED SOLID WASTE FACILITY. BECAUSE THEY
12 CAN BE REUSED, REMANUFACTURED, RECLAIMED, OR RECYCLED, WASTE
13 TIRES ARE A RECYCLABLE MATERIAL AS DEFINED IN SECTION 30-20-101
14 (4). AS RECYCLABLE MATERIALS, WASTE TIRES MUST BE COLLECTED,
15 MANAGED, AND TRANSPORTED IN ACCORDANCE WITH THE MANIFEST
16 SYSTEM REQUIRED BY SECTION 30-20-1417 (2) AND RECYCLED INTO
17 TIRE-DERIVED PRODUCT, THEREBY BEING TRANSFORMED FROM A
18 RECYCLABLE MATERIAL INTO A NEW PRODUCT. THE DEPARTMENT SHALL
19 CONSIDER TIRES THAT HAVE BEEN COLLECTED UNDER A TIRE COLLECTION
20 PROGRAM REGISTERED PURSUANT TO SECTION 30-20-1411 TO HAVE BEEN
21 MANAGED UNDER AN APPROVED ESTABLISHED TIRE COLLECTION PROGRAM
22 FOR PURPOSES OF THE FEDERAL COMMERCIAL INDUSTRIAL SOLID WASTE
23 INCINERATOR RULES, 40 CFR PART 60 SUBPARTS CCCC AND DDDD.

24 **30-20-1402. Definitions - repeal.** AS USED IN THIS PART 14,
25 UNLESS THE CONTEXT OTHERWISE REQUIRES:

26 (1) "BENEFICIAL USER" MEANS A PERSON WHO USES SOLID WASTE
27 AS AN INGREDIENT IN A MANUFACTURING PROCESS OR AS AN EFFECTIVE

1 SUBSTITUTE FOR NATURAL OR COMMERCIAL PRODUCTS, IN A MANNER
2 THAT DOES NOT POSE A THREAT TO HUMAN HEALTH OR THE
3 ENVIRONMENT. AVOIDANCE OF PROCESSING OR DISPOSAL COST ALONE
4 DOES NOT CONSTITUTE BENEFICIAL USE.

5 (2) "COMMISSION" MEANS THE SOLID AND HAZARDOUS WASTE
6 COMMISSION CREATED IN SECTION 25-15-302, C.R.S.

7 (3) "DEPARTMENT" MEANS THE DEPARTMENT OF PUBLIC HEALTH
8 AND ENVIRONMENT.

9 (4) "END USER" MEANS A PERSON WHO:

10 (a) USES A TIRE-DERIVED PRODUCT FOR A COMMERCIAL OR
11 INDUSTRIAL PURPOSE; ■

12 (b) USES A WHOLE WASTE TIRE TO GENERATE ENERGY OR FUEL; OR

13 (c) CONSUMES TIRE-DERIVED PRODUCT OR USES TIRE-DERIVED
14 PRODUCT IN ITS FINAL APPLICATION OR IN MAKING NEW MATERIALS.

15 (5) "MOBILE PROCESSOR" MEANS A PERSON WHO PROCESSES
16 WASTE TIRES AT A LOCATION OTHER THAN THE LOCATION OF THE PERSON'S
17 CERTIFICATE OF REGISTRATION.

18 (6) "MOTOR VEHICLE" MEANS A SELF-PROPELLED VEHICLE THAT
19 IS DESIGNED FOR TRAVEL ON THE PUBLIC HIGHWAYS AND THAT IS
20 GENERALLY AND COMMONLY USED TO TRANSPORT PERSONS AND
21 PROPERTY OVER THE PUBLIC HIGHWAYS OR A LOW SPEED ELECTRIC
22 VEHICLE. "MOTOR VEHICLE" INCLUDES AUTOMOBILES, MINIVANS, ALL
23 TRUCKS, MOTOR HOMES, AND MOTORCYCLES.

24 (7) "PUBLIC PROJECT" MEANS:

25 (a) A PUBLICLY FUNDED CONTRACT ENTERED INTO BY A
26 GOVERNMENTAL BODY OF THE EXECUTIVE BRANCH OF THIS STATE THAT
27 IS SUBJECT TO THE "PROCUREMENT CODE", ARTICLES 101 TO 112 OF TITLE

1 24, C.R.S.; AND

2 (b) A PUBLICLY FUNDED CONTRACT ENTERED INTO BY A COUNTY,
3 MUNICIPAL GOVERNMENT, OR SPECIAL DISTRICT, INCLUDING A SCHOOL
4 DISTRICT OR RECREATION DISTRICT.

5 (8) "TIRE" MEANS A RUBBER CUSHION THAT FITS AROUND A
6 WHEEL.

7 (9) "TIRE-DERIVED PRODUCT" MEANS MATTER THAT:

8 (a) IS DERIVED FROM A PROCESS THAT USES WHOLE TIRES AS A
9 FEEDSTOCK, INCLUDING SHREDDING, CRUMBING, AND CHIPPING;

10 (b) ADHERES TO ESTABLISHED ENGINEERING OR OTHER
11 APPROPRIATE SPECIFICATIONS OR TO ESTABLISHED PRODUCT END USER
12 SPECIFICATIONS OR CUSTOMER CONDITIONS OF ACCEPTANCE;

13 (c) HAS A DEMONSTRATED BENEFIT ASSOCIATED WITH THE END
14 USE;

15 (d) CAN BE USED AS A SUBSTITUTE FOR OR IN CONJUNCTION WITH
16 A COMMERCIAL PRODUCT OR RAW MATERIAL; AND

17 (e) HAS EITHER BEEN SOLD AND REMOVED FROM THE FACILITY OF
18 A PROCESSOR OR HAS BEEN USED ON SITE BY THE PROCESSOR.

19 (10) "TRAILER" MEANS A WHEELED VEHICLE, WITHOUT MOTIVE
20 POWER, THAT IS DESIGNED TO BE DRAWN BY A MOTOR VEHICLE.

21 (11) "USED TIRE" MEANS A TIRE THAT WAS PREVIOUSLY USED AS
22 A TIRE AND IS GRADED AND CLASSIFIED FOR REUSE AS A TIRE BASED ON
23 SPECIFICATIONS AND CRITERIA MAINTAINED PURSUANT TO SECTION
24 30-20-1410 (1) (a).

25 (12) "WASTE TIRE" MEANS A TIRE THAT IS MODIFIED FROM ITS
26 ORIGINAL SPECIFICATIONS BUT NOT PROCESSED INTO A TIRE-DERIVED
27 PRODUCT, IS NO LONGER BEING USED FOR ITS INITIAL INTENDED PURPOSE

1 AS A TIRE, AND IS NOT A USED TIRE.

2 (13) "WASTE TIRE CLEANUP PROGRAM" OR "PROGRAM" MEANS THE
3 PROGRAM CREATED BY THIS PART 14.

4 (14) "WASTE TIRE COLLECTION FACILITY" MEANS A FACILITY AT
5 WHICH WASTE TIRES ARE STORED AWAITING PICKUP BY A REGISTERED
6 WASTE TIRE HAULER FOR TRANSPORTATION TO A REGISTERED WASTE TIRE
7 PROCESSOR OR REGISTERED WASTE TIRE MONOFILL.

8 (15) "WASTE TIRE GENERATOR" MEANS A PERSON WHO GENERATES
9 WASTE TIRES. THE TERM INCLUDES NEW TIRE RETAILERS, USED TIRE
10 RETAILERS, AUTOMOBILE DEALERS, AUTOMOBILE DISMANTLERS, PUBLIC
11 AND PRIVATE VEHICLE MAINTENANCE SHOPS, GARAGES, SERVICE
12 STATIONS, CAR CARE CENTERS, AUTOMOTIVE FLEET CENTERS, LOCAL
13 GOVERNMENT FLEET OPERATORS, AND RENTAL FLEET OPERATORS.

14 (16) "WASTE TIRE HAULER" MEANS A PERSON WHO TRANSPORTS
15 TEN OR MORE WASTE TIRES IN ANY ONE LOAD.

16 (17) "WASTE TIRE MONOFILL" MEANS PART OR ALL OF A SOLID
17 WASTES DISPOSAL SITE AND FACILITY THAT HAS BEEN ISSUED A
18 CERTIFICATE OF DESIGNATION AND AT WHICH ONLY WASTE TIRES ARE
19 ACCEPTED.

20 (18) "WASTE TIRE PROCESSOR" MEANS A PERSON WHO PROCESSES
21 A WASTE TIRE INTO A TIRE-DERIVED PRODUCT.

22 **30-20-1403. Waste tire fee - distribution - rules.**

23 (1)(a) RETAILERS OF NEW MOTOR VEHICLE TIRES AND NEW TRAILER TIRES
24 SHALL COLLECT A WASTE TIRE FEE IN AN AMOUNT TO BE SET BY THE
25 COMMISSION, BY RULE, NOT TO EXCEED ONE DOLLAR AND FIFTY CENTS ON
26 THE SALE OF EACH NEW TIRE; EXCEPT THAT, EFFECTIVE ON AND AFTER
27 JANUARY 1, 2018, THE WASTE TIRE FEE IS FIFTY-FIVE CENTS ON THE SALE

1 OF EACH NEW TIRE. THE RECEIPT FROM THE RETAILER TO THE CUSTOMER
2 FOR EVERY NEW TIRE MUST CONTAIN THE FOLLOWING STATEMENT IN THE
3 LARGEST BOLD-FACED TYPE CAPABLE ON EXISTING INVOICE PRINTERS, NOT

1 **30-20-1404. Waste tire administration, enforcement, and**
2 **cleanup fund - creation - rules - repeal.** (1) THERE IS HEREBY CREATED
3 IN THE STATE TREASURY THE WASTE TIRE ADMINISTRATION,
4 ENFORCEMENT, AND CLEANUP FUND, REFERRED TO IN THIS SECTION AS THE
5 "FUND", CONSISTING OF THE FEE REVENUE CREDITED PURSUANT TO
6 SECTION 30-20-1403 (2) (a) (I) OR (2) (b) AND ANY OTHER MONEYS
7 APPROPRIATED TO IT. THE GENERAL ASSEMBLY SHALL ANNUALLY
8 APPROPRIATE THE MONEYS IN THE FUND TO THE DEPARTMENT FOR ITS
9 DIRECT AND INDIRECT ADMINISTRATIVE AND ENFORCEMENT COSTS IN
10 ADMINISTERING AND ENFORCING THIS PART 14. THE STATE TREASURER
11 SHALL CREDIT ALL INTEREST EARNED ON THE INVESTMENT OF MONEYS IN

24 (e) (I) SUBMITTING AN ANNUAL REPORT TO THE COMMITTEES OF
25 REFERENCE IN EACH HOUSE OF THE GENERAL ASSEMBLY WITH
26 JURISDICTION OVER TRANSPORTATION AND PUBLIC HEALTH, THE JOINT
27 BUDGET COMMITTEE, AND THE COMMISSION. THE REPORT MUST INCLUDE,

7 (F) THE STATUS OF ABATEMENT PROJECTS RANKED PURSUANT TO
8 SUBSECTION (6) OF THIS SECTION; AND

9 (G) AN ASSESSMENT OF THE IMPLEMENTATION OF PARAGRAPH (i)
10 OF THIS SUBSECTION (2).

11 (II) PURSUANT TO SECTION 24-1-136 (11), C.R.S., THIS
12 PARAGRAPH (e) IS REPEALED, EFFECTIVE SEPTEMBER 1, 2017.

13 (f) HIRING A CONTRACTOR TO CLEAN UP WASTE TIRES AND
14 TIRE-DERIVED PRODUCT THAT HAVE BEEN ILLEGALLY DISPOSED OF OR
15 HAVE BEEN DISPOSED OF AT A LANDFILL PURSUANT TO SECTION
16 30-20-1009 (2) AND FUNDING A GRANT PROGRAM TO REIMBURSE LOCAL
17 GOVERNING AUTHORITIES FOR CLEANING UP WASTE TIRES AND
18 TIRE-DERIVED PRODUCTS THAT HAVE BEEN ILLEGALLY DISPOSED OF OR
19 HAVE BEEN DISPOSED OF AT A LANDFILL PURSUANT TO SECTION
20 30-20-1009 (2);

7 pursuant to section ~~25-17-202~~ 30-20-1403, C.R.S., is exempt from
8 taxation under part 1 of this article.

9 **SECTION 10.** In Colorado Revised Statutes, **repeal** part 2 of
10 article 17 of title 25.

11 **SECTION 11.** (1) On July 1, 2014, the state treasurer shall
12 transfer the unobligated balances of the following funds, as they existed
13 on June 30, 2014, and before any transfer of the unexpended and
14 unencumbered moneys in the funds as specified in part 2 of article 17 of
15 title 25, Colorado Revised Statutes, as follows:

16 (a) The balances of the waste tire fee administration cash fund
17 created in section 25-17-202 (3) (c), Colorado Revised Statutes, waste tire
18 cleanup fund created in section 25-17-202.6 (1), Colorado Revised
19 Statutes, waste tire fire prevention fund created in section 25-17-202.8
20 (1), Colorado Revised Statutes, and law enforcement grant fund created
21 in section 25-17-207 (4), Colorado Revised Statutes, to the waste tire
22 administration, enforcement, and cleanup fund created in section
23 30-20-1404 (1), Colorado Revised Statutes;

24 (b) The balance of the processors and end users fund created in
25 section 25-17-202.5 (1), Colorado Revised Statutes, to the end users fund
26 created in section 30-20-1405 (1), Colorado Revised Statutes; and

27 (c) The balance of the waste tire market development fund created

1 in section 25-17-202.9 (1), Colorado Revised Statutes, to the waste tire
2 market development fund created in section 30-20-1406 (1), Colorado
3 Revised Statutes.

4 **SECTION 12.** In Colorado Revised Statutes, 43-2-402, **amend**
5 (5) (a) and (5) (b) as follows:

6 **43-2-402. Noise mitigation measures.** (5) (a) The department
7 shall construct noise mitigation measures on the list of approved measures
8 for which a local government has agreed to provide no less than fifty
9 percent of the necessary moneys in the order of priority established
10 pursuant to subsection (4) of this section, using moneys provided by local
11 governments and any moneys distributed to the department by the
12 department of public health and environment pursuant to part ~~2 of article~~
13 ~~17 of title 25~~ 14 OF ARTICLE 20 OF TITLE 30, C.R.S.

14 (b) After the construction of noise mitigation measures in
15 accordance with paragraph (a) of this subsection (5), the department shall
16 use any moneys provided by local governments or distributed to the
17 department pursuant to part ~~2 of article 17 of title 25~~ 14 OF ARTICLE 20 OF
18 TITLE 30, C.R.S., to construct other noise mitigation measures on the list
19 of approved measures in the order of priority established pursuant to
20 subsection (4) of this section.

21 **SECTION 13.** In Colorado Revised Statutes, **repeal** sections
22 30-20-121, 30-20-1006, 30-20-1007, and 30-20-1008.

23 **SECTION 14. Effective date - applicability.** This act takes
24 effect July 1, 2014, and applies to conduct occurring on or after said date.

25 **SECTION 15. Safety clause.** The general assembly hereby finds,
26 determines, and declares that this act is necessary for the immediate
27 preservation of the public peace, health, and safety.
