After consideration on the merits, the Committee recommends the following:

SB14-131 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 2, strike line 15 and substitute "~~registration card~~
2 ~~to sign an affirmation clause that appears on the registration. The clause~~
3 ~~shall state, "I swear or affirm in accordance with section 24-12-102,~~
4 ~~C.R.S. under penalty of perjury that I now have in effect a complying~~
5 ~~policy of motor vehicle insurance including an operator's policy pursuant~~
6 ~~to part 6 of article 4 of title 10, C.R.S., or a certificate of self-insurance~~
7 ~~to cover the vehicle or operator of the vehicle for which this registration~~
8 ~~is issued, and I understand that such insurance must be renewed so that~~
9 ~~coverage is continuous.~~
10 Signature _____, Date _____." REGISTERING
11 THE VEHICLE TO EITHER:".
- 12 Page 2, strike lines 18 through 26 and substitute:
13 "(b) PROVIDE PROOF OF INSURANCE UNDER PARAGRAPH (d) OF
14 SUBSECTION (1) OF THIS SECTION.".
- 15 Page 3, strike lines 1 and 2.
- 16 Page 3, line 4, after "(5)," insert "(7),".
- 17 Page 3, line 8, strike "~~and address~~" and substitute "OF THE OWNER and, IF
18 THE VEHICLE IS REGISTERED AS CLASS A PERSONAL PROPERTY, THE
19 address".

1 Page 3, line 21, strike "ADDRESS OR SIGNATURE." and substitute
2 "SIGNATURE OR ADDRESS UNLESS THE ADDRESS IS OF A VEHICLE
3 REGISTERED AS CLASS A PERSONAL PROPERTY."

4 Page 3, line 27, strike "CARD." and substitute "CARD; EXCEPT THAT THE
5 DEPARTMENT MAY PLACE THE PERSON'S ADDRESS ON THE CARD OF A
6 VEHICLE REGISTERED AS CLASS A PERSONAL PROPERTY.

7 (7) Within thirty days after moving from an address ~~or changing~~
8 ~~the name of the owner~~ listed upon a vehicle registration, a person shall
9 notify the county of residence in which the vehicle is to be registered. ~~in~~
10 ~~writing of the person's old and new address, including county, or old and~~
11 ~~new name, the registration numbers assigned to the vehicles for which the~~
12 ~~address is being changed, and the registration numbers for all~~
13 ~~registrations then held by such person."~~

14 Page 4, after line 11 insert:

15 "SECTION 3. In Colorado Revised Statutes, 42-4-1409, repeal
16 (7) as follows:

17 **42-4-1409. Compulsory insurance - penalty - legislative intent.**

18 (7) ~~The owner of a motor vehicle or low-power scooter, upon receipt of~~
19 ~~an affirmation of insurance as described in section 42-3-113 (2) and (3);~~
20 ~~shall sign and date such affirmation in the space provided."~~

21 Renumber succeeding sections accordingly.
