A BILL FOR AN ACT

101 CONCERNING THE CREATION OF THE SUICIDE PREVENTION
102 COMMISSION.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill creates the suicide prevention commission (commission) for the purpose of providing public and private leadership and recommendations regarding suicide prevention in Colorado. The commission will have members who represent the public and private sectors and who have experience with, or have been affected by, suicide

and suicide prevention. The department will provide administrative support to the commission. The bill requires the office of suicide prevention to include recommendations of the commission in its annual report to the general assembly and present the report in the annual SMART Act hearings.

The bill authorizes the department of public health and environment to receive gifts, grants, and donations for the costs associated with the implementation and duties of the commission.

1 Be it enacted by the General Assembly of the State of Colorado:

2 SECTION 1. Legislative declaration. The general assembly 3 finds and declares that suicide can be prevented, that the incidence of 4 suicide is extremely high in Colorado, and that suicide is a matter of 5 statewide concern and therefore requires further attention to educate the 6 public and provide resources to reduce the incidence of suicide. 7 SECTION 2. In Colorado Revised Statutes, add 25-1.5-111 as 8 follows: 9 25-1.5-111. Suicide prevention commission - created -10 responsibilities - gifts, grants, donations - repeal. (1) THE SUICIDE 11 PREVENTION COMMISSION IS HEREBY CREATED FOR THE PURPOSE OF: 12 (a) **PROVIDING PUBLIC AND PRIVATE LEADERSHIP FOR SUICIDE** 13 PREVENTION AND INTERVENTION IN COLORADO; 14 (b) SETTING STATEWIDE, <u>DATA-DRIVEN, EVIDENCE-BASED, AND</u> 15 CLINICALLY INFORMED SUICIDE PREVENTION PRIORITIES IN COLORADO; 16 (c) SERVING AS AN ADVISOR TO THE OFFICE OF SUICIDE 17 PREVENTION; 18 (d) ESTABLISHING AND LEADING SUBGROUPS TO SET STRATEGY 19 AND IMPLEMENTATION PLANS FOR EACH STATEWIDE SUICIDE PREVENTION 20 PRIORITY FOR THE OFFICE OF SUICIDE PREVENTION; 21 (e) PROVIDING A FORUM FOR GOVERNMENT AGENCIES,

13 (h) ENSURING THAT SUICIDE PREVENTION REMAINS A STATE14 PRIORITY; AND

15 (i) ENCOURAGING THE DEVELOPMENT OF SUICIDE PREVENTION
16 PLANS AT THE LOCAL LEVEL.

17 (2) (a) WITHIN <u>SIXTY</u> DAYS AFTER THE EFFECTIVE DATE OF THIS
18 <u>SECTION, THE EXECUTIVE DIRECTOR OF THE DEPARTMENT OF PUBLIC</u>
19 <u>HEALTH AND ENVIRONMENT SHALL APPOINT TO THE</u> COMMITTEE NO MORE
20 THAN <u>TWENTY-FIVE</u> MEMBERS, INCLUDING:

(I) A REPRESENTATIVE FROM THE OFFICE OF SUICIDE PREVENTION
IN THE DEPARTMENT, WHICH OFFICE SHALL SERVE AS THE ADMINISTRATOR
AND COORDINATOR OF THE COMMISSION;

1 (V) A REPRESENTATIVE FROM K-20 EDUCATION; 2 (VI)A REPRESENTATIVE FROM AN EMPLOYEE ASSISTANCE 3 PROGRAM OR A HUMAN RESOURCES DEPARTMENT FROM THE PRIVATE 4 SECTOR; 5 (VII) A REPRESENTATIVE FROM THE SUICIDE PREVENTION 6 COALITION OF COLORADO; 7 (VIII) A LICENSED MENTAL HEALTH PROFESSIONAL; 8 (IX) A REPRESENTATIVE FROM THE BEHAVIORAL HEALTH 9 TRANSFORMATION COUNCIL IN THE DEPARTMENT OF HUMAN SERVICES; 10 (X) AN ACTIVE MEMBER OR VETERAN OF THE UNITED STATES 11 MILITARY WHO HAS BEEN AFFECTED BY SUICIDE; 12 (XI) A REPRESENTATIVE FROM THE COLORADO YOUTH ADVISORY 13 COUNCIL: 14 (XII) A FAMILY MEMBER OF A PERSON WHO DIED BY SUICIDE; 15 (XIII) A PERSON WHO HAS ATTEMPTED SUICIDE, RECOVERED, AND 16 IS NOW THRIVING; 17 (XIV) A PERSON <u>REPRESENTING</u> A PHILANTHROPIC FOUNDATION; 18 (XV) A REPRESENTATIVE OF MEDICAL PROVIDERS OR FIRST 19 **RESPONDERS;** 20 (XVI) A REPRESENTATIVE FROM A HOSPITAL OR EMERGENCY 21 MEDICAL FACILITY; 22 (XVII) A REPRESENTATIVE FROM THE AGRICULTURAL, RANCHING, 23 OR OIL AND GAS INDUSTRY FROM A RURAL AREA; 24 (XVIII) AT LEAST TWO MEMBERS OF THE COLORADO BUSINESS 25 COMMUNITY, ONE OF WHOM REPRESENTS A RURAL AREA; 26 (XIX) ONE REPRESENTATIVE OF THE SUICIDE PREVENTION 27 NONPROFIT COMMUNITY;

8 (b)WHEN APPOINTING THE COMMISSION MEMBERS, THE 9 CO-CHAIRPERSONS SHALL ENSURE THAT THE REGIONS OF THE STATE WITH 10 HIGH SUICIDE RATES, INCLUDING RURAL AREAS, ARE REPRESENTED AND 11 THAT THE COMMISSION INCLUDES MEMBERS WITH EXPERTISE WITH GROUPS 12 ASSOCIATED WITH HIGH SUICIDE RATES AND SUICIDE ATTEMPTS, 13 INCLUDING: WORKING-AGE MEN; SENIOR ADULTS; VETERANS AND 14 ACTIVE-DUTY MILITARY PERSONNEL; LESBIAN, GAY, BISEXUAL, AND 15 TRANSGENDER YOUTHS; AND COLORADANS OF DISPROPORTIONATELY 16 AFFECTED DIVERSITIES AND GENDERS.

17 (c) THE MEMBERS OF THE COMMISSION SHALL SERVE WITHOUT
18 COMPENSATION; EXCEPT THAT THE MEMBERS MAY SEEK REIMBURSEMENT
19 FOR TRAVEL EXPENSES TO AND FROM MEETINGS OF THE COMMISSION.

20 THE DEPARTMENT SHALL PROVIDE TO THE COMMISSION (3) 21 SUPPORT THAT INCLUDES THE COORDINATION OF ALL COMMISSION 22 ACTIVITIES, INCLUDING: MEETING LOGISTICS, AGENDA DEVELOPMENT, 23 AND FOLLOW-UP; ORGANIZING AND ORIENTING COMMISSION MEMBERS; 24 WORKING CLOSELY WITH THE CO-CHAIRPERSONS TO SET PRIORITIES, 25 RECRUIT MEMBERS, OVERSEE ALL COMMISSION INITIATIVES, COORDINATE 26 ACTIVITIES, AND IMPLEMENT ANY COMMISSION-DIRECTED INITIATIVES; 27 AND ANY OTHER DUTIES ASSIGNED BY THE CO-CHAIRPERSONS. THE

DIRECTOR OF THE OFFICE OF BEHAVIORAL HEALTH IN THE DEPARTMENT OF
 HUMAN SERVICES, A REPRESENTATIVE FROM THE UNIVERSITY OF
 COLORADO DEPRESSION CENTER, AND A REPRESENTATIVE OF THE SUICIDE
 PREVENTION COALITION OF COLORADO MAY ALSO PROVIDE SUPPORT TO
 THE COMMISSION.

6 (4) THE OFFICE OF SUICIDE PREVENTION SHALL INCLUDE THE 7 RECOMMENDATIONS OF THE COMMISSION IN THE REPORT SUBMITTED 8 ANNUALLY TO THE GENERAL ASSEMBLY PURSUANT TO SECTION 25-1.5-101 9 AND SHALL PRESENT THE RECOMMENDATIONS AS PART OF ITS ANNUAL 10 PRESENTATION TO THE GENERAL ASSEMBLY PURSUANT TO THE "STATE 11 MEASUREMENT FOR ACCOUNTABLE, RESPONSIVE, TRANSPARENT 12 (SMART) GOVERNMENT ACT" AS ENACTED BY HOUSE BILL 10-1119 IN 13 2010.

14 THE DEPARTMENT MAY ACCEPT GIFTS, GRANTS, AND (5)15 DONATIONS FROM PUBLIC AND PRIVATE SOURCES FOR THE DIRECT AND 16 INDIRECT COSTS ASSOCIATED WITH THE IMPLEMENTATION AND DUTIES 17 ASSOCIATED WITH THE COMMISSION. THE DEPARTMENT SHALL TRANSMIT 18 ANY GIFTS, GRANTS, AND DONATIONS IT RECEIVES TO THE STATE 19 TREASURER, WHO SHALL CREDIT THE MONEYS TO THE SUICIDE PREVENTION 20 COORDINATION CASH FUND CREATED IN SECTION 25-1.5-101 (1) (w) (II). 21 THE FUND ALSO CONSISTS OF ANY MONEYS APPROPRIATED OR 22 TRANSFERRED TO THE FUND BY THE GENERAL ASSEMBLY FOR THE 23 PURPOSES OF THIS SECTION. THE MONEYS IN THE FUND ARE SUBJECT TO 24 ANNUAL APPROPRIATION BY THE GENERAL ASSEMBLY.

(6) (a) THIS SECTION IS REPEALED, EFFECTIVE SEPTEMBER 1, 2024.
(b) PRIOR TO THE REPEAL, THE DEPARTMENT OF REGULATORY
AGENCIES SHALL REVIEW THE COMMISSION PURSUANT TO SECTION
