The Senate Judiciary Committee Report (04/23/14) delays by six months the transfer of the responsibility for state paid respondent parent counsel to the newly created Office of Respondent Parents' Counsel (ORPC). The attached Fiscal Note assumes that the ORPC will need to be established four months prior to the transfer. Thus, with the transfer delayed to January 1, 2016, the ORPC would need to be established by September 1, 2015. As indicated in the attached Legislative Council Staff Memorandum dated April, 23, 2014¹, this delay eliminates the fiscal impact for FY 2014-15, and shifts the ORPC start-up and operational costs to FY 2015-16 (currently estimated to require up to \$500,000 General Fund and 2.0 FTE).

Points to Consider

Future Fiscal Impact

Although this bill would not require a General Fund appropriation for FY 2014-15, it is projected to require General Fund appropriations of up to \$500,000 and 2.0 FTE in FY 2015-16 to establish the ORPC. The bill requires the Judicial Department to include as part of its FY 2015-16 budget request the funding and staff necessary to establish the ORPC based on the recommendations of the Respondent Parents' Counsel Work Group. In addition, please note that the legislative declaration in the bill states that "there is a need to establish additional and equitable funding to compensate respondent parents' counsel", and that there should be an independent office to oversee the respondent parents' counsel to improve the quality of such representation. Thus, it is likely that the Department will request additional funding in future fiscal years if it is determined to be necessary to achieve the goals set forth in the bill.
