After consideration on the merits, the Committee recommends the following:

<u>HB14-1119</u> be amended as follows, and as so amended, be referred to the Committee on <u>Finance</u> with favorable recommendation:

- 1 Amend printed bill, page 2, after line 1 insert:
- 2 "SECTION 1. Legislative declaration. (1) The general
 3 assembly hereby finds and declares that:
- 4 (a) Colorado's major food banks are some of the most efficient
 5 and effective organizations in the state and distribute food to nearly two
 6 thousand nonprofit agencies statewide. In turn, those major food banks
 7 provide meals and services to people in need by way of diverse agencies
 8 such as food pantries, day care centers, battered women's shelters, soup
 9 kitchens, residential treatment centers, and senior and youth programs.
 10 Major food banks serve all ages and segments of our community.

(b) Colorado's food banks are experiencing historic demand.
Much of this demand has come from families and individuals who have
been forced to use this safety net for the first time, including victims of
Colorado's recent wild fire and flood disasters.

(c) Food banks from across Colorado have had extreme challenges
keeping their shelves stocked and have often been unable to provide the
basic necessities to those in need, particularly with respect to fresh
produce;

(d) According to a 2013 census bureau survey, almost fourteen
percent of the state's population, or almost seven hundred thousand
Coloradans, lived in poverty during 2012. This in includes eighteen
percent of all children under the age of eighteen. More than eight hundred
forty thousand Coloradans, or slightly more than sixteen percent of the
state's population, faced a time when there was not enough money to buy

1 food for themselves or their family in 2012.

(e) It is in the interest of the state to develop and support programs
that promote increased access to healthy food and increased consumption
of Colorado-grown products. Such increased access will improve child
and adult nutrition, promote a strong and healthy workforce, and help
address the obesity problems facing virtually every demographic in the
state.

8 (f) Colorado is home to some of the most productive farmlands 9 and hardest working farmers in the world. These farms and farming 10 families are critical to providing a healthy food supply and ensuring a 11 natural resource for Colorado's future generations.

(g) Colorado's fruit and vegetable growers and Colorado ranchers
want to do their part in helping Coloradans in need by helping them gain
more access to fresh, healthy food;

15 (h) Many of the state's farmers and ranchers would benefit from 16 a modest tax credit that would make it easier for them to donate more of 17 their fresh produce and incentivize more local growers to make the 18 financial and labor investment to donate their crops or livestock to 19 emergency food providers; and

(i) It is rare for Colorado's food banks to offer varying products
to the families they serve. In many neighboring states, similar tax credits
have helped food banks procure more diverse product donations.".

(3) FOR THE FOOD CONTRIBUTION TO THE HUNGER-RELIEF CHARITABLE
ORGANIZATION.".

- 4 COMMENCING ON OR AFTER JANUARY 1, 2015, BUT BEFORE JANUARY 1,
 5 2020, ANY".
- 6 Page 6, line 1, strike "(m)." and substitute "(m) FOR THE FOOD 7 CONTRIBUTION TO THE HUNGER-RELIEF CHARITABLE ORGANIZATION.".
