Bill Summary

Currently, a county clerk and recorder's office that issues a driver's license may retain \$8 of the fee. The bill allows the office to retain \$13.60

Be it enacted by the General Assembly of the State of Colorado: 1 2 **SECTION 1.** In Colorado Revised Statutes, 42-2-114, **amend** (4); 3 and repeal and reenact, with amendments, (2) as follows: 4 **42-2-114.** License issued - fees. (e), THROUGH FISCAL YEAR 2014-15, THE STATE TREASURER SHALL CREDIT
 THE ENTIRE AMOUNT TO THE LICENSING SERVICES CASH FUND.

3 (4) (a) (I) The fee for the issuance of a minor driver's license is
4 twenty dollars and forty cents. which THE license expires twenty days
5 after the LICENSEE'S twenty-first birthday. of the licensee.

1 motorcycle operator safety training fund is hereby created in the state 2 treasury. The fund consists of moneys collected under sections 42-2-114 3 (2) (b) (d) and (4) (b), 42-2-118 (1) (b) (II), and 42-3-304 (4), C.R.S. The 4 moneys in the fund are available immediately, without further 5 appropriation, for allocation by the transportation commission to the 6 office to be used for the implementation and administration of the 7 program. Moneys credited to the fund remain therein IN THE FUND at the 8 end of each fiscal year and are not transferred to any other fund.

9 SECTION <u>4.</u> Appropriation - adjustments to 2014 long bill.
10 (1) For the implementation of this act, the general fund appropriation
11 made in the annual general appropriation act to the controlled
12 maintenance trust fund created in section 24-75-302.5 (2) (a), Colorado
13 Revised Statutes, for the fiscal year beginning July 1, 2014, is decreased
14 by \$61,264.

(2) In addition to any other appropriation, there is hereby
appropriated, out of any moneys in the general fund, not otherwise
appropriated, to the department of revenue, for the fiscal year beginning
July 1, 2014, the sum of \$61,264, or so much thereof as may be necessary,
to be allocated to the division of motor vehicles, driver services, for
personal services related to the implementation of this act.

(3) In addition to any other appropriation, there is hereby
appropriated, out of any moneys in the Colorado state titling and
registration account of the highway users tax fund created in section
42-1-211 (2), Colorado Revised Statutes, not otherwise appropriated, to
the department of revenue, for the fiscal year beginning July 1, 2014, the
sum of \$6,592, or so much thereof as may be necessary, to be allocated
for the purchase of computer center services for the implementation of

2	(4) In addition to any other appropriation, there is hereby
3	appropriated to the governor - lieutenant governor - state planning and
4	budgeting, for the fiscal year beginning July 1, 2014, the sum of \$6,592,
5	or so much thereof as may be necessary, for allocation to the office of
6	information technology, for the provision of computer center services for
7	the department of revenue related to the implementation of this act. Said
8	sum is from reappropriated funds received from the department of
9	revenue out of the appropriation made in subsection (3) of this section.
10	SECTION 5. Effective date - applicability. (1) (a) Except as
11	otherwise provided in this section, this act takes effect July 1, 2014.
12	(b) Section 1 of this act takes effect only if Senate Bill 14-194
13	does not become law.
14	(c) Section 2 of this act takes effect only if Senate Bill 14-194
15	becomes law.
16	(2) This act applies to driver's licenses issued on or after the
17	applicable effective date of this act.
18	SECTION 6. Safety clause. The general assembly hereby finds,
19	determines, and declares that this act is necessary for the immediate
20	preservation of the public peace, health, and safety.
