	CONCERNING THE RENAMING OF THE TUNNELS LOCATED WITHIN CLEAR CREEK COUNTY AND COMMONLY REFERRED TO AS THE	
	TWIN TUNNELS AS THE "VETERANS MEMORIAL TUNNELS".	
	WHEREAS, Colorado has a proud and distinguished history of	
	dedicated military service by men and women of this state whose courage,	
	heroism, and  sacrifice  preserve  the  liberties  and  democratic  way  of  life  set	
	forth in our state and federal constitutions; and	
	WHEREAS, Colorado benefits significantly from the presence and	
	military service of the more than 60,000 men and women in our state who	
	serve in the United States Army, Navy, Air Force, Marine Corps, and	
	Coast Guard; the branch Reserves; the Colorado National Guard; and the	

1 2	WHEREAS, In addition to active members of the Armed Services, Colorado is the proud home of more than 426,000 military veterans who
3 4	have served their country long and well and who bring great honor and distinction to the state; and

5	WHEREAS, Colorado is home not only to active duty service
6 7	personnel and veterans but also to the countless family members of these men and women who display the same dedication, courage, and sacrifice;

9	WHEREAS, Clear Creek County, one of the original territorial
10	counties in Colorado, has a long history of involvement with active duty
11	service personnel and veterans; and
12	WHEREAS, The roads and highways that run through Clear Creek
13 14	County have seen the footsteps of militia soldiers going to serve in the Civil War and the vehicles of soldiers going to serve in World War I and
15	World War II; and

16	WHEREAS, The Clear Creek County roads have seen the return
17	of these soldiers, who would build the state's mining industry in the 19th
18 19	century and the ski industry in the 20th century due to the skill and knowledge of the 10th Mountain Division troops; and
19	knowledge of the Toth Mountain Division troops, and
20	WHEREAS, The portion of Interstate 70 that runs through Clear
21	Creek County, and that includes the tunnels commonly known as the
22	Twin Tunnels, was part of the original Victory Highway established in
23 24	1921 in honor of the American forces who lost their lives in World War I; and

25	WHEREAS, This section of Interstate 70 was also designated as
26	a Blue Star Highway in the 1940s in honor of those who served during
27	World War II; and
28	WHEREAS, Colorado should also never forget the sacrifices made
29	by its 94 men declared missing in action or prisoners of war while
30	defending the principles of liberty and justice during the Cold War and
31	the conflicts in Korea, Laos, and Vietnam; and
32	WHEREAS, Between 1950 and 2006, 641 Coloradans were killed
33	in action and 101 Coloradans were wounded in action, and the state

1	should never forget the sacrifices of those 742 soldiers; and
2	WHEREAS, In times of conflict around the globe, it is particularly
3	appropriate to recognize the Coloradans in all branches and components
4	of the Armed Services who serve around the world to protect the security
5	and peace of our nation and other nations; now, therefore,
6	Be It Resolved by the Senate of the Sixty-ninth General Assembly
7	of the State of Colorado, the House of Representatives concurring herein:
8	(1) That the tunnels located within Clear Creek County, on
9	Interstate 70, commonly referred to as the Twin Tunnels, be designated
10	at the east and west entrances as the "Veterans Memorial Tunnels";
11	(2) That the Colorado Department of Transportation may accept
12	and expend gifts, grants, and donations for the purposes of the initial
13	placement of signs to mark the Twin Tunnels as the "Veterans Memorial
14	Tunnels";
15	(3) That the Colorado Department of Transportation may explore
16	a cooperative agreement with the Board of County Commissioners for
17	Clear Creek County for the maintenance of the markings for the
18	"Veterans Memorial Tunnels"; and
19	(4) That such signage be installed and erected at the conclusion of
20	the planned construction and widening of the so-named "Veterans
21	Memorial Tunnels".
22	Be It Further Resolved, That copies of this Joint Resolution be sent
