SENATE JOINT RESOLUTION 14-022

101 CONCERNING THE RECOGNITION AND COMMENDATION OF THE PEOPLE  
102 OF COLORADO AND THE UNITED STATES ON THE 100TH  
103 ANNIVERSARY OF THE ESTABLISHMENT OF ROCKY MOUNTAIN  
104 NATIONAL PARK.

1 WHEREAS, 100 years ago, groups of citizens and officials in  
2 Colorado displayed great foresight in recognizing the potential benefits  
3 of a national park in the southern Rocky Mountains; and

4 WHEREAS, On January 26, 1915, President Woodrow Wilson  
5 signed the Rocky Mountain National Park Act, creating Rocky Mountain  
6 National Park (RMNP) in the state of Colorado; and

7 WHEREAS, The fragile alpine tundra encompasses one-third of

1 RMNP and is one of the largest examples of alpine tundra ecosystems  
2 preserved in the National Park System in the lower 48 states; and

3 WHEREAS, RMNP serves as a place for visitors to enjoy 359  
4 miles of hiking trails, 150 lakes, scenic drives, and extensive wildlife  
5 viewing; and

6 WHEREAS, The National Park Service provides unique outdoor  
7 education within RMNP that provides visitors with opportunities to learn  
8 about the diverse park ecosystems, environmental stewardship, wilderness  
9 areas, and the principles of Leave No Trace; and

10 WHEREAS, RMNP is an internationally recognized biosphere  
11 reserve with scientific interest and significance, where biological and  
12 cultural resources represent a natural laboratory of extraordinary diversity  
13 in which researchers can explore and make discoveries for the benefit of  
14 present and future generations; and

15 WHEREAS, RMNP has a higher average altitude than any other  
16 national park in the United States, with at least 60 mountains higher than  
17 12,000 feet, including Longs Peak, which stands at a massive 14,259 feet;  
18 and

19 WHEREAS, The Continental Divide runs through RMNP, and the  
20 park contains the headwaters of several river systems, including the  
21 Colorado River; and

22 WHEREAS, Trail Ridge Road, RMNP's highway to the sky, spans  
23 48 miles, 11 miles of which are above treeline, and peaks at an  
24 astounding 12,183 feet; and

25 WHEREAS, Trail Ridge Road provides access to breathtaking  
26 views, an abundance of wildlife, and spectacular alpine wildflower  
27 exhibitions; is one of 10 America's Byways; and is a designated All  
28 American Roadway; and

29 WHEREAS, On March 30, 2009, 95% of RMNP was designated  
30 as wilderness, thereby conferring the highest level of conservation  
31 protection for federal lands in order to protect the park's majestic terrain  
32 from future development; and

33 WHEREAS, More than 170 million visitors have visited RMNP

1 since its establishment in 1915, and the park continues to serve the people  
2 of Colorado, the United States, and the world with a place of outstanding  
3 natural beauty and refuge; and

4 WHEREAS, The National Park Service will continue its long  
5 tradition of protecting and providing enjoyment to citizens with the  
6 wilderness, wildlife, and wonder found within RMNP, inspiring  
7 stewardship in future generations for the next hundred years and beyond;  
8 and

9 WHEREAS, In 1909, reflecting on the beauty of RMNP, Enos  
10 Mills wrote, "In years to come when I am asleep beneath the pines,  
11 thousands of families will find rest and hope in this park"; and

12 WHEREAS, More than one century later, RMNP is the most  
13 popular attraction in Colorado, drawing 3 million annual visitors to its  
14 416 square miles of mountain beauty; and

15 WHEREAS, This anniversary marks the celebration of more than  
16 100 years of work by many committed stakeholders, from the local  
17 communities to the federal government; now, therefore,

18 *Be It Resolved by the Senate of the Sixty-ninth General Assembly*  
19 *of the State of Colorado, the House of Representatives concurring herein:*

20 (1) That the Colorado General Assembly:

21 (a) Honors the 100th anniversary of the signing of the Rocky  
22 Mountain National Park Act;

23 (b) Recognizes more than 100 years of work by many committed  
24 stakeholders, from local communities to the federal government; and

25 (c) Commends the National Park Service and so many Coloradans  
26 for their dedication to preserving this region of the southern Rocky  
27 Mountains for future generations.

28 *Be it further resolved* that copies of this Joint Resolution be sent  
29 to the National Park Service; the Board of Trustees of Grand Lake,  
30 Colorado; the Board of Trustees of Granby, Colorado; and the Board of  
31 Trustees of Estes Park, Colorado.
