A BILL FOR AN ACT

101 **CONCERNING THE COLORADO FRAUD INVESTIGATORS UNIT.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at <http://www.leg.state.co.us/billsummaries>.)

Currently there is a surcharge on all uniform commercial code filings with the secretary of state to fund the Colorado fraud investigators unit (unit) in the Colorado bureau of investigation. The bill increases the surcharge from \$3 to \$4 for 3 years starting July 1, 2014. During the 3 years, the bill requires the department of public safety to report on the activities of the unit at its "Smart Measurement for Accountable, Responsive, and Transparent (SMART) Government Act" hearing.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-33.5-1707,
3 **amend** (2) (a) as follows:

4 **24-33.5-1707. Funding - cash fund created - donations - repeal.**

5 (2) (a) (I) (A) There is hereby established, beginning August 1, 2006, a
6 surcharge of three dollars, in addition to all other lawful charges and fees,
7 to be paid on each filing on every electronic or paper uniform commercial
8 code filing with the secretary of state.

9 (B) NOTWITHSTANDING THE PROVISIONS OF SUB-SUBPARAGRAPH
10 (A) OF THIS SUBPARAGRAPH (I), FROM JULY 1, 2014, THROUGH JUNE 30,
11 2017, THE SURCHARGE IS FOUR DOLLARS. THIS SUB-SUBPARAGRAPH (B)
12 IS REPEALED, EFFECTIVE JULY 1, 2018.

13 (II) The moneys collected by the surcharge shall immediately be
14 transmitted to the state treasurer for deposit in the cash fund.

15 **SECTION 2.** In Colorado Revised Statutes, 24-33.5-1704, **add**
16 (7) as follows:

17 **24-33.5-1704. Colorado fraud investigators unit - creation -**

18 **duties - repeal.** (7) (a) BEGINNING IN 2014, AND EVERY YEAR
19 THEREAFTER THROUGH 2017, THE DEPARTMENT OF PUBLIC SAFETY SHALL
20 REPORT ON THE ACTIVITIES OF THE UNIT AS PART OF ITS "STATE
21 MEASUREMENT FOR ACCOUNTABLE, RESPONSIVE, AND TRANSPARENT
22 (SMART) GOVERNMENT ACT" HEARING REQUIRED BY SECTION 2-7-203,
23 C.R.S.

24 (b) THIS SUBSECTION (7) IS REPEALED, EFFECTIVE JULY 1, 2018.

25 **SECTION 3. Effective date.** This act takes effect July 1, 2014.

26 **SECTION 4. Safety clause.** The general assembly hereby finds,

- 1 determines, and declares that this act is necessary for the immediate
- 2 preservation of the public peace, health, and safety.
