interactions with the United States armed forces by advocating for the state's involvement in current and potential military missions, supporting private Colorado businesses that bid for contracts with the United States military, and assisting the state's congressional delegation in protecting Colorado's current United States armed forces commands from future military base realignments or closures.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, **add** 24-48.5-120 as  
3 follows:

4           **24-48.5-120. Maintain relationship with United States armed**  
5 **forces - legislative declaration.** (1) (a) THE GENERAL ASSEMBLY HEREBY  
6 FINDS AND DECLARES THAT:

7           (I) THE DEFENSE SECTOR IS ONE OF THE STATE'S LARGEST  
8 ECONOMIC SECTORS, WITH AN IMPACT EXCEEDING TEN BILLION DOLLARS  
9 PER YEAR;

10           (II) THE UNITED STATES MILITARY PRESENCE IN THE STATE IS  
11 DIRECTLY RESPONSIBLE FOR THE MAJORITY OF THE ECONOMIC ACTIVITY  
12 IN CONNECTION WITH THE DEFENSE SECTOR;

13           (III) THE DEFENSE SECTOR, UNLIKE MOST SECTORS OF THE STATE'S  
14 ECONOMY, IS DISPROPORTIONATELY IMPACTED BY DECISIONS MADE IN  
15 WASHINGTON, D.C.;

16           (IV) THE BRANCHES OF THE UNITED STATES ARMED SERVICES ARE  
17 FACING MULTIPLE YEARS OF DECLINING BUDGETS AND ARE MAKING  
18 IMPORTANT DECISIONS ABOUT WHERE TO CONDUCT NECESSARY ACTIVITIES  
19 AND PROGRAMS;

20           (V) STATES ACROSS THE COUNTRY ARE PLACING GREATER FOCUS  
21 ON THE DEFENSE SECTOR AND ARE CREATING STRONGER COMPETITION FOR  
22 JOBS TIED TO THAT SECTOR; AND

1           (VI) THE DEFENSE INDUSTRY IS EXPERIENCING CONSOLIDATIONS  
2 AND ALSO MAKING DECISIONS ABOUT WHERE IT WILL CONTINUE TO  
3 OPERATE.

4           (b) THE GENERAL ASSEMBLY FURTHER FINDS AND DECLARES THAT  
5 THE COLORADO OFFICE OF ECONOMIC DEVELOPMENT IS ABLE TO HELP THE  
6 STATE PROTECT AND GROW ITS ECONOMY BY BEING FULLY ENGAGED IN  
7 SUPPORTING THE DEFENSE SECTOR.

8           (2) IN ADDITION TO THE POWERS AND DUTIES SPECIFIED IN SECTION  
9 24-48.5-101, THE COLORADO OFFICE OF ECONOMIC DEVELOPMENT SHALL  
10 PROTECT AND GROW THE STATE'S ECONOMY BY BEING FULLY ENGAGED IN  
11 SUPPORTING THE DEFENSE SECTOR AND INFLUENCING THE DEFENSE  
12 SECTOR DECISION MAKING PROCESSES THAT OCCUR AT THE FEDERAL  
13 LEVEL. THE OFFICE SHALL MAINTAIN THE STATE'S POSITIVE INTERACTIONS  
14 WITH THE UNITED STATES ARMED FORCES BY ADVOCATING FOR THE  
15 STATE'S INVOLVEMENT IN CURRENT AND POTENTIAL MILITARY MISSIONS,  
16 SUPPORTING PRIVATE COLORADO BUSINESSES THAT BID FOR CONTRACTS  
17 WITH THE UNITED STATES ARMED FORCES, AND ASSISTING THE STATE'S  
18 CONGRESSIONAL DELEGATION IN PROTECTING COLORADO'S CURRENT  
19 UNITED STATES ARMED FORCES COMMANDS FROM FUTURE MILITARY BASE  
20 REALIGNMENTS OR CLOSURES.

21           **SECTION 2. Safety clause.** The general assembly hereby finds,  
22 determines, and declares that this act is necessary for the immediate  
23 preservation of the public peace, health, and safety.
