1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-34-109, **amend**
3 (7) as follows:

4 **24-34-109. Nurse-physician advisory task force for Colorado**
5 **health care - creation - duties - definition.** (7) This section is repealed,
6 effective ~~July 1, 2014~~ SEPTEMBER 1, 2020. Prior to ~~such~~ THE repeal, the
7 DEPARTMENT OF REGULATORY AGENCIES SHALL REVIEW THE functions of
8 the NPATCH ~~shall be reviewed~~ as provided in section 2-3-1203, C.R.S.

9 **SECTION 2.** In Colorado Revised Statutes, 2-3-1203, **repeal** (3)
