A BILL FOR AN ACT

101 CONCERNING TRANSFERS OF MONEYS RELATED TO CAPITAL CONSTRUCTION.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Joint Budget Committee. For the 2014-15 fiscal year, the bill transfers \$219,993,465 from the general fund to the capital construction fund and \$500,000 from the general fund exempt account of the general fund to the capital construction fund.

For the 2014-15 fiscal year, the bill transfers \$1 million from the

state historical fund to the capital construction fund for historical renovations of the state house of representatives' chambers and the state senate's chambers.

1 Be it enacted by the General Assembly of the State of Colorado: 2 **SECTION 1.** In Colorado Revised Statutes, 24-75-302, amend 3 (2) introductory portion, (2) (z), (2.5) introductory portion, (2.5) (g), and 4 (2.5) (h); and **add** (2) (aa), (2.5) (i), and (2.7) as follows: 5 24-75-302.
