101 **CONCERNING THE RECATEGORIZATION OF MINERAL COUNTY FOR THE**  
102 **PURPOSE OF STATUTORY PROVISIONS FIXING THE SALARIES OF**  
103 **COUNTY OFFICERS.**

**Bill Summary**

For the purpose of establishing the salaries of officers, the counties of the state are divided into 6 categories. Currently, Mineral county is a "category VI" county. The bill recategorizes Mineral county as a "category V" county and specifies the condition upon which the

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 30-2-102, **amend** (1)  
3 (e) and (1) (f) as follows:

4 **30-2-102. Categorization of counties for fixing salaries of**  
5 **county officers.** (1) For the purpose of establishing the salaries of county  
6 officers:

7 (e) Category V counties shall consist of the counties of Baca,  
8 Bent, Cheyenne, Conejos, Costilla, Crowley, Hinsdale, Lincoln,  
9 MINERAL, Phillips, Saguache, and San Juan;

10 (f) Category VI counties shall consist of the counties of Dolores,  
11 Jackson, Kiowa, ~~Mineral~~, and Sedgwick.

12 **SECTION 2. Act subject to petition - effective date.** (1) Except  
13 as otherwise provided in subsection (2) of this section, this act takes  
14 effect at 12:01 a.m. on the day following the expiration of the ninety-day  
15 period after final adjournment of the general assembly (August 6, 2014,  
16 if adjournment sine die is on May 7, 2014); except that, if a referendum  
17 petition is filed pursuant to section 1 (3) of article V of the state  
18 constitution against this act or an item, section, or part of this act within  
19 such period, then the act, item, section, or part will not take effect unless  
20 approved by the people at the general election to be held in November  
21 2014 and, in such case, will take effect on the date of the official  
22 declaration of the vote thereon by the governor.

23 (2) This act takes effect only if the annual salaries of county

1 officers, as set forth in section 30-2-102, Colorado Revised Statutes, are  
2 not increased more than 10% by legislation enacted during the 2014  
3 legislative session.
