A BILL FOR AN ACT

101 CONCERNING THE CONFIDENTIALITY OF SOCIAL SECURITY NUMBERS
102 UNDER THE "COLORADO CONSUMER PROTECTION ACT".

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill:

- ! Prohibits an entity with a board of directors, including an advisory board, from requiring an unpaid member of the board to disclose his or her social security number to the entity in order to serve as a member of the board;

- ! Makes it unlawful for the state or any local government to deny an individual a right, benefit, or privilege provided by law because the individual refuses to disclose his or her social security number;
- ! Requires the state or any local government that requests an individual to disclose his or her social security number to inform the individual whether the disclosure is mandatory or voluntary, by what statutory or other authority the social security number is solicited, and what uses will be made of the individual's social security number; and
- ! Clarifies that Colorado's statute on confidentiality of social security numbers does not apply with respect to patient information for entities subject to the federal "Health Insurance Portability and Accountability Act of 1996".

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 6-1-715, **amend** (4)
 3 introductory portion and (4) (b); and **add** (1.5) and (3.5) as follows:

4 **6-1-715. Confidentiality of social security numbers.** (1.5) AN
 5 ENTITY WITH A BOARD OF DIRECTORS, INCLUDING ANY ADVISORY BOARD,
 6 SHALL NOT REQUIRE A MEMBER OF THE BOARD OF DIRECTORS WHO IS NOT
 7 PAID FOR SERVING ON THE BOARD, EXCEPT FOR OCCASIONAL
 8 REIMBURSEMENT OF INCIDENTAL EXPENSES OF SERVING ON THE BOARD,
 9 TO DISCLOSE THE MEMBER'S SOCIAL SECURITY NUMBER TO THE ENTITY IN
 10 ORDER TO SERVE AS A MEMBER OF THE BOARD.

11 (3.5) IT IS UNLAWFUL FOR THE STATE OR ANY LOCAL GOVERNMENT
 12 TO DENY AN INDIVIDUAL ANY RIGHT, BENEFIT, OR PRIVILEGE PROVIDED BY
 13 LAW BECAUSE OF THE INDIVIDUAL'S REFUSAL TO DISCLOSE HIS OR HER
 14 SOCIAL SECURITY NUMBER. THE STATE OR ANY LOCAL GOVERNMENT THAT
 15 REQUESTS AN INDIVIDUAL TO DISCLOSE HIS OR HER SOCIAL SECURITY
 16 NUMBER SHALL INFORM THE INDIVIDUAL WHETHER THAT DISCLOSURE IS
 17 MANDATORY OR VOLUNTARY, BY WHAT STATUTORY OR OTHER AUTHORITY

1 THE SOCIAL SECURITY NUMBER IS SOLICITED, AND WHAT USES WILL BE
2 MADE OF THE INDIVIDUAL'S SOCIAL SECURITY NUMBER.

3 (4) This section ~~shall~~ DOES not apply to:

4 (b) WITH RESPECT TO PATIENT INFORMATION, an entity that is
5 subject to the federal "Health Insurance Portability and Accountability
6 Act of 1996", as amended, 42 U.S.C. sec. 1320d to 1320d-9.

7 **SECTION 2. Act subject to petition - effective date -**
8 **applicability.** (1) This act takes effect at 12:01 a.m. on the day following
9 the expiration of the ninety-day period after final adjournment of the
10 general assembly (August 6, 2014, if adjournment sine die is on May 7,
11 2014); except that, if a referendum petition is filed pursuant to section 1
12 (3) of article V of the state constitution against this act or an item, section,
13 or part of this act within such period, then the act, item, section, or part
14 will not take effect unless approved by the people at the general election
15 to be held in November 2014 and, in such case, will take effect on the
16 date of the official declaration of the vote thereon by the governor.

17 (2) This act applies to acts occurring on or after the applicable
18 effective date of this act.
