A BILL FOR AN ACT

101CONCERNING AUTHORIZATION FOR THE PARKS AND WILDLIFE102COMMISSION TO PURCHASE REAL PROPERTY TO BUILD A

103 MULTI-USE SHOOTING FACILITY.

Bill Summary

The bill authorizes the parks and wildlife commission to purchase property to build a multi-use shooting facility using appropriated funds, non-appropriated grant funds, or federal moneys.

1	Be it enacted by the General Assembly of the State of Colorado:
2	SECTION 1. In Colorado Revised Statutes, 33-1-105, add (1) (i)
3	as follows:
4	33-1-105. Powers of commission - repeal. (1) The commission
5	has power to:
6	(i) (I) PURCHASE REAL PROPERTY IN MESA COUNTY KNOWN AS
7	TAX PARCELS 2709-271-00-081, 2709-274-00-082, 2709-281-00-083,
8	2709-284-00-084, and 2709-273-00-087 to build a multi-use
9	SHOOTING FACILITY USING FUNDS OR OTHER MONEYS RECEIVED FROM:
10	(A) APPROPRIATED FUNDS OR NONAPPROPRIATED GRANT MONEYS;
11	OR
12	(B) THE FEDERAL GOVERNMENT.
13	(II) THIS PARAGRAPH (i) IS REPEALED, EFFECTIVE JULY 1, 2020.
14	SECTION 2. Act subject to petition - effective date. This act
15	takes effect at 12:01 a.m. on the day following the expiration of the
16	ninety-day period after final adjournment of the general assembly (August
17	6, 2014, if adjournment sine die is on May 7, 2014); except that, if a
18	referendum petition is filed pursuant to section 1 (3) of article V of the
19	state constitution against this act or an item, section, or part of this act
20	within such period, then the act, item, section, or part will not take effect
21	unless approved by the people at the general election to be held in
22	November 2014 and, in such case, will take effect on the date of the
23	official declaration of the vote thereon by the governor.
