**A BILL FOR AN ACT**

101 **CONCERNING AUTHORIZATION FOR THE PARKS AND WILDLIFE**  
102 **COMMISSION TO PURCHASE REAL PROPERTY TO BUILD A**  
103 **MULTI-USE SHOOTING FACILITY.**

**Bill Summary**

The bill authorizes the parks and wildlife commission to purchase property to build a multi-use shooting facility using appropriated funds, non-appropriated grant funds, or federal moneys.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 33-1-105, **add** (1) (i)  
3 as follows:

4 **33-1-105. Powers of commission - repeal.** (1) The commission  
5 has power to:

6 (i) (I) PURCHASE, WITHOUT USING THE BID PROCESS REQUIRED BY  
7 SECTION 33-1-105.5, NO MORE THAN TWO THOUSAND ACRES OF REAL  
8 PROPERTY IN MESA COUNTY TO BUILD A MULTI-USE SHOOTING FACILITY  
9 USING MONEYS RECEIVED FROM:

10 (A) APPROPRIATED FUNDS OR NONAPPROPRIATED GRANT MONEYS;

11 OR

12 (B) THE FEDERAL GOVERNMENT.

13 (II) THE COMMISSION MAY CONTRACT WITH AN INDEPENDENT  
14 CONTRACTOR TO BUILD OR OPERATE THE MULTI-USE SHOOTING FACILITY  
15 AUTHORIZED BY THIS PARAGRAPH (i).

16 (III) THE AUTHORITY TO PURCHASE LAND UNDER SUBPARAGRAPH  
17 (I) OF THIS PARAGRAPH (i) EXPIRES ON JULY 1, 2020, BUT THIS EXPIRATION  
18 DOES NOT AFFECT THE AUTHORITY TO BUILD AND OPERATE OR TO  
19 CONTRACT TO BUILD AND OPERATE THE MULTI-USE SHOOTING FACILITY.

20 **SECTION 2.** In Colorado Revised Statutes, 2-3-1304, **amend** (1)  
21 (a.3) (III) as follows:

22 **2-3-1304. Powers and duties of capital development**  
23 **committee.** (1) The capital development committee has the following  
24 powers and duties:

25 (a.3) To review and make required recommendations on reports  
26 from state agencies, including reports from:

1 (III) The parks and wildlife commission in the department of  
2 natural resources on the acquisition of certain real property interests  
3 pursuant to UNDER section 33-1-105 (1) (i) OR (3) (a), C.R.S., and the  
4 acquisition of certain interest in real property or water pursuant to section  
5 33-1-105.5 (9), C.R.S.; and

6 **SECTION 3. Act subject to petition - effective date.** This act  
7 takes effect at 12:01 a.m. on the day following the expiration of the  
8 ninety-day period after final adjournment of the general assembly (August  
9 6, 2014, if adjournment sine die is on May 7, 2014); except that, if a  
10 referendum petition is filed pursuant to section 1 (3) of article V of the  
11 state constitution against this act or an item, section, or part of this act  
12 within such period, then the act, item, section, or part will not take effect  
13 unless approved by the people at the general election to be held in  
14 November 2014 and, in such case, will take effect on the date of the  
15 official declaration of the vote thereon by the governor.
