101 **CONCERNING THE EXEMPTION OF YOGA TEACHER TRAINING FROM**  
102 **REGULATION UNDER STATUTES GOVERNING PRIVATE**  
103 **OCCUPATIONAL EDUCATION, AND, IN CONNECTION THEREWITH,**  
104 **REDUCING AN APPROPRIATION.**

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 12-59-104, **amend**

3 (1) (q); and **add** (1) (s) as follows:

4 **12-59-104. Exemptions.** (1) The following educational  
5 institutions and educational services are exempt from the provisions of  
6 this article:

7 (q) A private educational institution that is accredited by an  
8 agency recognized by the United States department of education, that  
9 confers post-graduate degrees, and that offers programs or courses that  
10 are not defined as occupational education pursuant to section 12-59-103  
11 (8.5); and

12 (s) YOGA TEACHER TRAINING COURSES, PROGRAMS, AND SCHOOLS.

13 **SECTION 2. Appropriation - adjustments to 2015 long bill. To**  
14 **implement this act, the appropriation made in the annual general**  
15 **appropriation act for the 2015-16 state fiscal year to the department of**  
16 **higher education for the division of private occupational schools is**  
17 **decreased by \$13,349. This appropriation is from the private occupational**  
18 **schools fund created in section 12-59-116, C.R.S.**

19 **SECTION 3. Safety clause.** The general assembly hereby finds,  
20 determines, and declares that this act is necessary for the immediate  
21 preservation of the public peace, health, and safety.
