A BILL FOR AN ACT

101 **CONCERNING MAKING PERMANENT THE STATE BOARD OF LAND**
102 **COMMISSIONERS' AUTHORITY TO SELL STATE TRUST LAND TO**

Bill Summary

In 2010, a law was enacted that allowed the state board of land commissioners (board) to convey land to units of local government if the conveyance would add value to adjoining or nearby state trust property, benefit board operations, or comply with local land use regulations. When enacted, the authority was set to repeal on July 1, 2015. The bill repeals

2 **SECTION 1.** In Colorado Revised Statutes, 36-1-124.3, **repeal**
3 (5) as follows:

4 **36-1-124.3. Acquisition of state trust lands by governmental**
5 **entities - repeal.** (5) **This section is repealed, effective July 1, 2015 JULY**
6 **1, 2020, UNLESS THE STATE BOARD OF LAND COMMISSIONERS FILES A**
7 **WRITTEN REPORT REGARDING ALL PROPERTY DISPOSALS MADE PURSUANT**
8 **TO THIS SECTION ON JANUARY 6, 2020, TO THE GENERAL ASSEMBLY AS**
9 **SPECIFIED IN SECTION 24-1-136 (9), C.R.S.**

10 **SECTION 2. Safety clause.** The general assembly hereby finds,
11 determines, and declares that this act is necessary for the immediate
12 preservation of the public peace, health, and safety.
