Amend printed bill, page 3, line 3, strike "DEGREE;" and substitute
 "DEGREE, PRE-APPRENTICESHIP CERTIFICATE, OR OTHER
 INDUSTRY-RECOGNIZED CERTIFICATE ALLOWING STUDENTS TO GAIN
 CAREER RELEVANT EXPERIENCE;".

5 Page 3, after line 19 insert:

6 "(2) "CERTIFIED CENTER OF LEARNING" MEANS AN EMPLOYER 7 THAT ENTERS INTO AN AGREEMENT WITH A P-TECH SCHOOL AND UNDERGOES A THIRD-PARTY CERTIFICATION PROCESS PROVING THAT THEY 8 9 ARE QUALIFIED TO ASSIST THE LOCAL EDUCATION PROVIDER IN CREATING 10 AND PROVIDING WORKPLACE EDUCATION EXPERIENCES AND TRAINING. 11 WHICH EXPERIENCES AND TRAINING MAY INCLUDE BUT NEED NOT BE 12 LIMITED TO JOB SHADOWING, MENTORING, INTERNSHIPS, AND 13 APPRENTICESHIPS.".
