After consideration on the merits, the Committee recommends the following:

HB15-1318 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend printed bill, page 2, line 2, strike "25.5-10-204.5" and substitute
2 "25.5-6-409.3".

3 Page 2, line 4, strike "**25.5-10-204.5**" and substitute "**25.5-6-409.3**".

4 Page 3, lines 8 and 9, strike "ADMINISTER A SINGLE CONSOLIDATED" and
5 substitute "ESTABLISH A REDESIGNED".

6 Page 3, line 12, strike "SINGLE CONSOLIDATED" and substitute
7 "REDESIGNED".

8 Page 3, strike lines 14 through 27 and substitute:

9 "(3) THE REDESIGNED WAIVER MUST INCLUDE FLEXIBLE SERVICE
10 DEFINITIONS, PROVIDE ACCESS TO SERVICES AND SUPPORTS WHEN AND
11 WHERE THEY ARE NEEDED, OFFER SERVICES AND SUPPORTS BASED ON THE
12 INDIVIDUAL'S NEEDS AND PREFERENCES, AND INCORPORATE THE
13 FOLLOWING PRINCIPLES:

14 (a) FREEDOM OF CHOICE OVER LIVING ARRANGEMENTS AND
15 SOCIAL, COMMUNITY, AND RECREATIONAL OPPORTUNITIES;

16 (b) INDIVIDUAL AUTHORITY OVER SUPPORTS AND SERVICES;

17 (c) SUPPORT TO ORGANIZE RESOURCES IN WAYS THAT ARE
18 MEANINGFUL TO THE INDIVIDUAL RECEIVING SERVICES;

19 (d) HEALTH AND SAFETY ASSURANCES;

1 (e) OPPORTUNITY FOR COMMUNITY CONTRIBUTION; AND
2 (f) RESPONSIBLE USE OF PUBLIC DOLLARS."

3 Page 4, strike lines 1 through 4.

4 Page 4, before line 5 insert:

5 "(3.5) THE REDESIGNED WAIVER MUST ENSURE CONTINUITY OF
6 SUPPORT, INCLUDING RESIDENTIAL SERVICES, FOR ELIGIBLE INDIVIDUALS
7 ENROLLED IN THE HOME- AND COMMUNITY-BASED SERVICES WAIVERS
8 SERVING ADULTS WITH INTELLECTUAL AND DEVELOPMENTAL DISABILITIES
9 WHO WERE RECEIVING SERVICES AS OF JANUARY 1, 2016, AND WHO HAVE
10 MAINTAINED WAIVER ELIGIBILITY."

11 Page 4, lines 15 and 16, strike "IN COLLABORATION WITH" and substitute
12 "WITH INPUT FROM".

13 Page 4, line 16, after "BOARDS," insert "SINGLE ENTRY POINT AGENCIES,
14 AND OTHER STAKEHOLDERS,".
