A BILL FOR AN ACT

CONCERNING ESTABLISHING THE CO9TO25 YOUTH DEVELOPMENT COUNCIL.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. The bill establishes the CO9To25 youth development council (council). The goal of the council is to improve the health and well-being of youth and young adults across Colorado by uniting and maximizing collective interests and resources. The membership and operational structure of the council shall be determined by the council in accordance with recommendations from the Colorado state youth development plan.
