The Senate Business, Labor, and Technology Committee Report (02/10/15) increased the number of members on the cosmetology advisory committee from five to six, updates the criteria for advisory committee membership, and increases the number of hours of training that an applicant for licesure must complete prior to examination. The bill offsets the costs associated with the increase in committee members by the reducing the number of mandatory committee meetings from four to one. Legislative Council Staff and JBC Staff agree that the committee amendments do not change the fiscal impact of the bill.

This provision also appropriates a total of \$8,506 reappropriated funds to the Department of Law to provide legal services to the Department of Regulatory Agencies.
