- 3 Page 4, line 17, strike "JULY 1, 2015." and substitute "JULY 1, 2017.".
- 4 Page 6, strike lines 13 through 15.
- 5 Renumber succeeding subparagraphs accordingly.
- 6 Page 6, line 25, strike "MAY" and substitute "SHALL".
- 7 Page 7, line 6, strike "AND".
- 8 Page 7, line 10, strike "GOAL." and substitute "GOAL; AND".
- 9 Page 7, after line 10 insert:
- "(III) WHETHER THERE ARE ANY OPPORTUNITIES TO IMPROVE THE
 EFFECTIVENESS OF THE TAX EXPENDITURE IN MEETING ITS PURPOSE,
 INTENT, OR GOAL.".
- 13 Page 7, strike lines 11 through 27 and substitute:

EXPENDITURES EVALUATED IN THE PREVIOUS EVALUATION REPORT AND
AN EVALUATION OF ANY NEW TAX EXPENDITURES ENACTED BY THE
GENERAL ASSEMBLY SINCE THE PREVIOUS EVALUATION REPORT.".

15 Page 8, strike lines 1 through 10 and substitute:

16 "(b) BY DECEMBER 15, 2017, AND BY DECEMBER 15 EVERY FIVE
17 YEARS THEREAFTER, THE COMMITTEE SHALL MEET TO CONSIDER THE
18 EVALUATION REPORT SUBMITTED BY THE STATE AUDITOR OR THE
19 EVALUATION CONTRACTOR. THE COMMITTEE MUST HOLD A".

- Page 8, line 16, after "SESSION." add "THE COMMITTEE MAY MEET AS

 EVALUATION REPORTS.".
- 25 Page 9, strike lines 1 through 3 and substitute:
- 26 "(6) THE DEPARTMENT OF REVENUE MUST PROVIDE".
- Page 9, line 4, strike "DATA" and substitute "DATA, IF AVAILABLE ANDUNDER THE CONTROL OF THE DEPARTMENT,".
- 29 Page 9, line 11, after "C.R.S." add "OTHER STATE AGENCIES MAY PROVIDE
- 30 INFORMATION OR DATA AS REQUESTED BY THE COMMITTEE, THE STATE31 AUDITOR, OR THE EVALUATION CONTRACTOR.".
- 32 Page 9, line 12, strike "LEGISLATIVE COUNCIL" and after "STAFF" insert
