## **Current Appropriations Clause in Bill**

The bill requires but does not contain an appropriation clause.

### **Description of Amendments in This Packet**

**J.001** Staff has prepared amendment **J.001** (attached) to add a provision appropriating a total of \$546,114 General Fund to the Legislative Department for FY 2015-16. This provision also states that the appropriation is based on the assumption that the Department will require an additional 5.6 FTE to implement the act. The moneys are to be used by the Office of the State Auditor to produce a tax expenditure review for the Tax Expenditure Evaluation Committee established by this bill, as well as to staff the Committee.

#### **Points to Consider**

#### General Fund Impact

The Joint Budget Committee has proposed a budget package for FY 2015-16 based on the March 2015 Legislative Council Staff revenue forecast. The budget package allocates a total of \$18.5

million General Fund to be available to fund 2015 legislation. If the full \$18.5 million is not used to fund legislation, it will remain in the General Fund reserve.
