Current Appropriations Clause in Bill

The bill requires but does not contain an appropriation clause.

Description of Amendments in This Packet

- **J.001** Staff has prepared amendment **J.001** (attached) to add a provision appropriating a total of \$1,331,712 General Fund to the Department of Personnel for FY 2015-16. This provision also states that the appropriation is based on the assumption that the Department will require an additional 0.5 FTE.
- **L.004** Sponsor amendment **L.004** adds a provision that clarifies the definition of "contract" for the purposes of the bill.

L.005 and J.002

Sponsor amendment **L.005** adds a provision that allows the Department to accept gifts, grants, and donations for the study.

Staff has prepared sponsor-requested amendment **J.002** (attached) to add a provision appropriating a total of \$666,667 General Fund and \$333,333 cash funds anticipated to come from gifts, grants, and donations to the Department of Personnel for FY 2015-16. This provision also states that the appropriation is based on the assumption that the Department will require an additional 0.5 FTE. Amendment J.002 provides \$968,288 rather than \$1.3 million for vendor contract costs for the study. Legislative Council staff states that this amount is approximately in the lower range of costs of studies reviewed to arrive at an estimated cost for the study in the Legislative Council Staff fiscal note. Additionally, Legislative Council staff states that the Department will seek to contract with a vendor for as many as possible of the study components outlined in the bill with the amount appropriated.

The Committee may adopt either amendment J.001 $\underline{\text{or}}$ J.002. The Committee should adopt J.002 if amendment L.005 is adopted.

Points to Consider

General Fund Impact

The Joint Budget Committee has proposed a budget package for FY 2015-16 based on the March 2015 Legislative Council Staff revenue forecast. The budget package allocates a total of \$18.5 million General Fund to be available to fund 2015 legislation. If the full \$18.5 million is not used to fund legislation, it will remain in the General Fund reserve.
