Summary of Legislation

The bill requires that the Department of Higher Education (DHE) create a higher education sexual assault task force. The task force includes students, administrators, victim advocates, and higher education law enforcement officers. The task force will study affirmative consent and other sexual assault policies and submit a report to the General Assembly by July 1, 2016.

State Expenditures

The bill increases state expenditures in the DHE by \$84,665 and 0.2 FTE in FY 2015-16 only. New costs are for a program assistant in the department to coordinate task force efforts and to arrange and facilitate meetings. The task force will consist of up to 20 stakeholder representatives who will receive reimbursement for travel, per diem, and other meeting expenses. Finally, the DHE must contract with a third-party evaluator to prepare the final report, at the direction of the ta`sk force. All costs are displayed in Table 1.

Centrally appropriated costs. Pursuant to a Joint Budget Committee policy, certain costs associated with this bill are addressed through the annual budget process and centrally appropriated in the Long Bill or supplemental appropriations bills, rather than in this bill. The centrally appropriated costs subject to this policy are estimated in the fiscal note for informational purposes and summarized in Table 2.
