After consideration on the merits, the Committee recommends the following:

HB15-1322 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

1 Amend printed bill, page 2, line 12, after the period insert "THE  
2 DEPARTMENT SHALL ENSURE THAT THE ENTITY THAT IT CONTRACTS WITH  
3 FOR PURPOSES OF THIS SECTION IS NOT AFFILIATED IN ANY MANNER WITH  
4 AN ENTITY THAT COLLECTS OR PROCESSES DATA OF ANY TYPE FOR THE  
5 DEPARTMENT, A SCHOOL DISTRICT, THE STATE CHARTER SCHOOL  
6 INSTITUTE, OR A CHARTER SCHOOL."

7 Page 2, line 17, strike "AND".

8 Page 2, strike line 20 and substitute "DISTRICTS;

9 (d) RECOMMEND GUIDELINES AND MEASURES FOR PROTECTING  
10 STUDENT PRIVACY AS IT RELATES TO THE DATA THAT SCHOOL DISTRICTS,  
11 BOARDS OF COOPERATIVE SERVICES, AND CHARTER SCHOOLS REPORT AND  
12 THE DEPARTMENT MAINTAINS;

13 (e) RECOMMEND SECURITY PROTOCOLS THAT SCHOOL DISTRICTS,  
14 BOARDS OF COOPERATIVE SERVICES, CHARTER SCHOOLS, AND THE  
15 DEPARTMENT SHOULD FOLLOW IN SUBMITTING AND MANAGING DATA;

16 (f) RECOMMEND GUIDELINES FOR RETAINING DATA, INCLUDING  
17 THE LENGTH OF TIME FOR WHICH SCHOOL DISTRICTS, BOARDS OF  
18 COOPERATIVE SERVICES, CHARTER SCHOOLS, AND THE DEPARTMENT MAY  
19 RETAIN DATA; AND

20 (g) RECOMMEND THE GENERAL PURPOSES OF DATA COLLECTION TO  
21 GUIDE DECISIONS REGARDING WHETHER TO REQUIRE SCHOOL DISTRICTS,  
22 BOARDS OF COOPERATIVE SERVICES, AND CHARTER SCHOOLS TO COLLECT  
23 DATA."
