A BILL FOR AN ACT

101 CONCERNING THE ALLOWABLE USES OF MONEYS IN THE GENERAL  
102 FUND EXEMPT ACCOUNT THAT ARE DESIGNATED TO BENEFIT  
103 STUDENTS ATTENDING INSTITUTIONS OF HIGHER EDUCATION.

Bill Summary

**Joint Budget Committee.** The general fund exempt account consists of an amount of moneys equal to the amount of state revenues that the state retains and spends under the authority the voters conferred through their approval of referendum C in 2005. The general assembly is annually required to appropriate 1/3 of the moneys in the account for

community colleges and other institutions of higher education. The bill expands the allowable areas of higher education-related appropriations to include:

- ! Work-study programs;
- ! Tuition for qualified Indian pupils who attend Fort Lewis college;
- ! Local district junior college grants; and
- ! Area vocational school grants.

2 **SECTION 1.** In Colorado Revised Statutes, 24-77-104.5, **amend**  
3 (4) (a) (IV) and (4) (a) (V); and **add** (4) (a) (VI), (4) (a) (VII), (4) (a)  
4 (VIII), and (4) (a) (IX) as follows:

5 **24-77-104.5. General fund exempt account - appropriations to**  
6 **critical needs fund - specification of uses for health care and**  
7 **education - definitions.** (4) (a) Funding for the benefit of students  
8 attending community colleges and other institutions of higher education,  
9 as used in subparagraph (III) of paragraph (b) of subsection (1) of this  
10 section, shall be limited to funding for:

11 (IV) Fee-for-service contracts authorized pursuant to section  
12 23-18-303, C.R.S.; and

13 (V) Capital construction projects related to higher education;

14 (VI) WORK-STUDY PROGRAMS;

15 (VII) TUITION FOR QUALIFIED INDIAN PUPILS WHO ATTEND FORT  
16 LEWIS COLLEGE;

17 (VIII) LOCAL DISTRICT JUNIOR COLLEGE GRANTS; AND

18 (IX) AREA VOCATIONAL SCHOOL GRANTS.

19 **SECTION 2. Safety clause.** The general assembly hereby finds,
