Bill Summary

Currently, heavy-duty diesel vehicles are exempt from testing until their fourth model year. The bill extends this exemption to the sixth model year if the gross vehicle weight is at least 26,000 pounds and is a

Requirement of certification of emissions control for 5 registration - testing for diesel smoke opacity compliance. 6 (1) (b) (II) Notwithstanding the provisions of subparagraph (I) of this 7 paragraph (b), new diesel vehicles, required under this section to have a 8 certification of emissions control, shall be issued a certification of 9 emissions compliance without inspection or testing. 5	(August 5, 2015, if adjournment sine die is on May 6, 2015); except that,
6	if a referendum petition is filed pursuant to section 1 (3) of article V of
7	the state constitution against this act or an item, section, or part of this act
8	within such period, then the act, item, section, or part will not take effect
9	unless approved by the people at the general election to be held in
10	November 2016 and, in such case, will take effect on the date of the
11	official declaration of the vote thereon by the governor.
