Water Resources Review Committee. The bill directs the Colorado water conservation board (CWCB), in consultation with the division of planning in the department of local affairs (DOLA), to:

Develop and provide free training programs, on a recurring basis, for local government water use, water demand, and

land use planners regarding best management practices for water demand management and water conservation; and Make recommendations regarding how to better integrate

Make recommendations regarding how to better integrate water demand management and conservation planning into land use planning, including, as appropriate, legislative, regulatory, and guidance or policy recommendations.

The CWCB and the Colorado water resources and power development authority, in determining whether to render financial assistance to a local governmental water supply entity, must consider whether the entity's planners, if it has any, have taken the training and are actively applying it in their planning decisions.

1 *Be it enacted by the General Assembly of the State of Colorado:* 2 3 **SECTION 1.** In Colorado Revised Statutes, 37-60-126, amend 4 (4) introductory portion, (4) (d), and (4) (e); and add (4) (f) as follows: 5 37-60-126. Water conservation and drought mitigation 6 planning - programs - relationship to state assistance for water 7 facilities - guidelines - water efficiency grant program - repeal. (4) A plan developed by a covered entity pursuant to subsection (2) of this 8 9 section shall MUST, at a minimum, include a full evaluation of the 10 following plan elements: 11 (d) The time period, not to exceed seven years, after which the 12 covered entity will review and update its adopted plan; and 13 (e) Either as a percentage or in acre-foot increments, an estimate 14 of the amount of water that has been saved through a previously 15 implemented conservation plan and an estimate of the amount of water 16 that will be saved through conservation when the plan is implemented; 17 <u>AND</u> 18 (f) (I) BEST MANAGEMENT PRACTICES FOR WATER DEMAND 19 MANAGEMENT, WATER EFFICIENCY, AND WATER CONSERVATION THAT

19	SECTION 2. Appropriation. For the 2015-16 state fiscal year,
20	\$50,000 is appropriated to the department of natural resources for use by
21	the Colorado water conservation board. This appropriation is from the
22	Colorado water conservation board construction fund created in section
23	37-60-121 (1) (a), C.R.S. To implement this act, the Colorado water
24	conservation board may use this appropriation for the water conservation
25	program.
26	SECTION 3. Act subject to petition - effective date -
27	applicability. (1) This act takes effect at 12:01 a.m. on the day following

the expiration of the ninety-day period after final adjournment of the 1 2 general assembly (August 5, 2015, if adjournment sine die is on May 6, 3 2015); except that, if a referendum petition is filed pursuant to section 1 4 (3) of article V of the state constitution against this act or an item, section, or part of this act within such period, then the act, item, section, or part 5 6 will not take effect unless approved by the people at the general election 7 to be held in November 2016 and, in such case, will take effect on the date of the official declaration of the vote thereon by the governor. 8

(2) This act applies to conduct occurring on or after the applicable effective date of this act.
