**A BILL FOR AN ACT**

101 **CONCERNING THE POSTPONEMENT OF JURY SERVICE FOR A PERSON**  
102 **WHO IS BREAST-FEEDING A CHILD.**

**Bill Summary**

The bill permits a person who is breast-feeding a child to be temporarily excused from jury service for up to 2 years. The judge or jury commission may require documentation in support of the postponement.

1           **SECTION 1.** In Colorado Revised Statutes, 13-71-119.5, **add**  
2 (2.5) as follows:

3           **13-71-119.5. Persons entitled to be excused from jury service.**

4 (2.5) A PERSON WHO IS BREAST-FEEDING A CHILD AND IS TEMPORARILY  
5 UNABLE TO OR CHOOSES NOT TO LEAVE THE CHILD IN ORDER TO SERVE ON  
6 A JURY MUST BE EXCUSED TEMPORARILY FROM SERVICE AS A JUROR FOR  
7 UP TO TWO CONSECUTIVE TWELVE-MONTH POSTPONEMENTS. THE JUDGE  
8 OR JURY COMMISSIONER MAY REQUEST A PHYSICIAN'S NOTE OR MEDICAL  
9 STATEMENT IN SUPPORT OF THE POSTPONEMENT. A PHYSICIAN'S NOTE OR  
10 MEDICAL STATEMENT PROVIDED PURSUANT TO THIS SUBSECTION (2.5) IS  
11 NOT A PUBLIC RECORD AND MUST NOT BE DISCLOSED TO THE PUBLIC.

12           **SECTION 2. Safety clause.** The general assembly hereby finds,  
13 determines, and declares that this act is necessary for the immediate  
14 preservation of the public peace, health, and safety.
