101 **CONCERNING CONTINUATION OF THE COMPLIANCE ADVISORY PANEL,**  
102 **AND, IN CONNECTION THEREWITH, IMPLEMENTING THE**  
103 **RECOMMENDATIONS OF THE DEPARTMENT OF REGULATORY**  
104 **AGENCIES AS CONTAINED IN THE 2014 SUNSET REPORT.**

the compliance advisory panel for 11 years, until 2026. In addition, the bill establishes that future sunset reviews for the compliance advisory panel are pursuant to the standards set for advisory boards rather than the standards set for regulatory agencies and functions. The bill clarifies that the compliance advisory panel advises, not oversees, the small business stationary source technical and environmental compliance assistance program. The bill extends compliance advisory panel members' terms from 2 years to 3 years.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 2-3-1203, **add** (3)  
3 (mm) as follows:

4           **2-3-1203. Sunset review of advisory committees.** (3) The  
5 following dates are the dates on which the statutory authorization for the  
6 designated advisory committees is scheduled for repeal:

7           (mm) SEPTEMBER 1, 2026:

8           (I) THE COMPLIANCE ADVISORY PANEL TO THE AIR POLLUTION  
9 CONTROL DIVISION IN THE DEPARTMENT OF PUBLIC HEALTH AND  
10 ENVIRONMENT CREATED IN SECTION 25-7-109.2, C.R.S.

11           **SECTION 2.** In Colorado Revised Statutes, 25-7-109.2 **amend**  
12 (2) (d), (4), and (6) as follows:

13           **25-7-109.2. Small business stationary source technical and**  
14 **environmental compliance assistance program - repeal.** (2) There is  
15 hereby created a compliance advisory panel, which shall:

16           (d) ~~Oversee~~ ADVISE the small business stationary source technical  
17 and environmental compliance assistance program, which shall serve as  
18 the secretariat for the development and dissemination of such reports and  
19 advisory opinions.

20           (4) The terms of those members of the panel initially appointed by  
21 the governor, the speaker of the house of representatives, and the minority

1 leader of the house of representatives shall expire on January 31, 1994.  
2 The terms of those members initially appointed by the president of the  
3 senate, the minority leader of the senate, and the executive director of the  
4 department of public health and environment shall expire on January 31,  
5 1995. Thereafter, members of the panel shall serve for terms of ~~two~~  
6 THREE years, such terms to commence on February 1 of the year of  
7 appointment. Vacancies occurring during the term of office of any  
8 member of the panel shall be filled for the unexpired portion of the  
9 regular term in the same manner as for the original appointment.

10 (6) The general assembly finds, determines, and declares that this  
11 section is enacted for purposes of compliance with the provisions of  
12 section 507 of the federal act, 42 U.S.C. sec. 7661f. Subsections (2), (3),  
13 and (4) of this section and this subsection (6) are repealed, effective ~~July~~  
14 ~~1, 2015~~ SEPTEMBER 1, 2026. Prior to said repeal, the compliance advisory  
15 panel shall be reviewed by a legislative committee of reference,  
16 designated pursuant to section 2-3-1201, C.R.S., to conduct the review  
17 pursuant to section ~~24-34-104~~ 2-3-1203, C.R.S.

18 **SECTION 3.** In Colorado Revised Statutes, 24-34-104, **repeal**  
19 (46) (d) as follows:

20 **24-34-104. General assembly review of regulatory agencies**  
21 **and functions for termination, continuation, or reestablishment.**

22 (46) The following agencies, functions, or both shall terminate on July  
23 1, 2015:

24 (d) ~~The compliance advisory panel to the air pollution control~~  
25 ~~division in the department of public health and environment created in~~  
26 ~~section 25-7-109.2, C.R.S.;~~

27 **SECTION 4. Effective date.** This act takes effect July 1, 2015.

1           **SECTION 5. Safety clause.** The general assembly hereby finds,  
2 determines, and declares that this act is necessary for the immediate  
3 preservation of the public peace, health, and safety.
