A BILL FOR AN ACT

101 **CONCERNING THE AMOUNT A VETERAN MUST PAY TO ENTER STATE**
102 **PARKS, AND, IN CONNECTION THEREWITH, MAKING AN**
103 **APPROPRIATION.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Currently, the parks and wildlife commission (commission) may issue rules permitting veterans free entrance to state parks or recreation areas one day per year. The bill requires the commission to promulgate rules allowing veterans free entrance to state parks or recreation areas on a 3-day weekend coinciding with the observance of Veterans' Day.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 33-12-106, add (2.4)
3 as follows:

4 **33-12-106. Park entrance privileges - identified veterans -**
5 **wounded warriors - search and rescue organizations conducting**
6 **training activities - legislative declaration - rules.** (2.4) (a) THE
7 COMMISSION SHALL PROMULGATE A RULE TO ALLOW VETERANS,
8 INCLUDING ACTIVE DUTY PERSONNEL, FREE ENTRANCE TO ANY STATE
9 PARK OR RECREATION AREA, NOT TO INCLUDE CAMPGROUNDS, YURTS, OR
10 OTHER AMENITIES AND SERVICES, FOR THE MONTH OF AUGUST EACH YEAR.
11 THE COMMISSION MAY PROMULGATE A RULE SETTING EVIDENCE
12 STANDARDS TO SHOW A PERSON IS A VETERAN AND ISSUE A STICKER OR
13 OTHER DEVICE THAT IDENTIFIES A PERSON AS A VETERAN FOR FUTURE
14 ENTRANCE. THE COMMISSION MAY ALSO CHARGE A FEE FOR ISSUING THE
15 STICKER OR OTHER DEVICE THAT IDENTIFIES A PERSON AS A VETERAN, BUT
16 THE FEE MUST BE BASED ON THE DIRECT AND INDIRECT COST OF ISSUING
17 THE STICKER OR OTHER DEVICE.

18 (b) THE GENERAL ASSEMBLY SHALL ANNUALLY APPROPRIATE
19 MONEYS TO THE DIVISION TO IMPLEMENT THIS SUBSECTION (2.4). IF THE
20 GENERAL ASSEMBLY DOES NOT MAKE THE APPROPRIATION, THE
21 COMMISSION NEED NOT OFFER FREE ENTRANCE TO VETERANS TO STATE
22 PARKS OR RECREATIONAL AREAS UNTIL THE MONEY IS APPROPRIATED.

23 **SECTION 2. Appropriation.** For the 2015-16 state fiscal year,
24 \$150,000 is appropriated to the department of natural resources for use
25 by the division of parks and wildlife. This appropriation is from the
26 general fund. To implement this act, the department may use this

1 appropriation for state park operations.

2 **SECTION 3. Safety clause.** The general assembly hereby finds,

3 determines, and declares that this act is necessary for the immediate

4 preservation of the public peace, health, and safety.
