- ! January 1, 2019 - \$11.50
- ! January 1, 2020 - \$12.50

1 *Be It Resolved by the House of Representatives of the Seventieth*
2 *General Assembly of the State of Colorado, the Senate concurring herein:*

3 **SECTION 1.** At the election held on November 8, 2016, the
4 secretary of state shall submit to the registered electors of the state the
5 ballot title set forth in section 2 for the following amendment to the state
6 constitution:

7 In the constitution of the state of Colorado, **amend** section 15 of
8 article XVIII as follows:

9 **Section 15. State minimum wage rate.** (1) (a) Effective
10 January 1, ~~2007~~ 2017, Colorado's minimum wage shall be increased to
11 ~~\$6.85~~ \$9.50 per hour. ~~and~~

12 (b) EFFECTIVE JANUARY 1, 2018, COLORADO'S MINIMUM WAGE
13 SHALL BE INCREASED TO \$10.50 PER HOUR.

14 (c) EFFECTIVE JANUARY 1, 2019, COLORADO'S MINIMUM WAGE
15 SHALL BE INCREASED TO \$11.50 PER HOUR.

16 (d) EFFECTIVE JANUARY 1, 2020, COLORADO'S MINIMUM WAGE
17 SHALL BE INCREASED TO \$12.50 PER HOUR.

18 (2) EFFECTIVE JANUARY 1, 2021, THE MINIMUM WAGE shall be
19 ~~adjusted~~ INCREASED annually for inflation, as measured by the Consumer
20 Price Index used for Colorado.

21 (3) ~~This~~ THE minimum wage IN SUBSECTION (1) OF THIS SECTION
22 shall be paid to employees who receive the state or federal minimum

1 wage.

2 (4) No more than \$3.02 per hour in tip income may be used to
3 offset the minimum wage of employees who regularly receive tips.

4 **SECTION 2.** Each elector voting at the election may cast a vote
5 either "Yes/For" or "No/Against" on the following ballot title: "Shall
6 there be an amendment to the Colorado constitution concerning an
7 increase in the statewide minimum wage, and, in connection therewith,
8 raising the minimum wage to \$9.50 on January 1, 2017, \$10.50 on
9 January 1, 2018, \$11.50 on January 1, 2019, and \$12.50 on January 1,
10 2020?".

11 **SECTION 3.** Except as otherwise provided in section 1-40-123,
12 Colorado Revised Statutes, if a majority of the electors voting on the
13 ballot title vote "Yes/For", then the amendment will become part of the
14 state constitution.
