1 **SECTION 1.** In Colorado Revised Statutes, 24-75-302, **amend**
2 (2) introductory portion, (2) (z), and (2) (aa); and **add** (2) (bb) as follows:

3 **24-75-302. Capital construction fund - capital assessment fees**
4 **- calculation - repeal.** (2) On July 1 of each year through ~~July 1, 2014~~
5 APRIL 1, 2015, the state treasurer and the controller shall transfer a sum
6 as specified in this subsection (2) out of the general fund and into the
7 capital construction fund as moneys become available in the general fund
8 during the fiscal year beginning on said July 1. Transfers between funds
9 pursuant to this subsection (2) are not appropriations subject to the
10 limitations of section 24-75-201.1. The amounts transferred pursuant to
11 this subsection (2) are as follows:

12 (z) On July 1, 2013, one hundred eighty-six million two hundred
13 fifteen thousand four hundred ninety-three dollars; ~~and~~

14 (aa) On July 1, 2014, two hundred twenty-four million nine
15 hundred ninety-three thousand four hundred sixty-five dollars; AND

16 (bb) ON APRIL 1, 2015, TWENTY-THREE MILLION EIGHT THOUSAND
17 THREE HUNDRED THIRTY-TWO DOLLARS.

18 **SECTION 2. Safety clause.** The general assembly hereby finds,
19 determines, and declares that this act is necessary for the immediate
20 preservation of the public peace, health, and safety.
