A BILL FOR AN ACT

101 **CONCERNING CAPITAL-RELATED TRANSFERS OF MONEYS.**

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. Joint Budget Committee. For the 2013-14 fiscal year, the bill changes \$84,639,619 of that fiscal year's general fund transfer to a general fund exempt transfer because those moneys were for capital construction appropriations related to higher education.

For the 2015-16 fiscal year, the bill transfers:

- ! \$144,682,149 from the general fund to the capital construction fund;
- ! \$76,877,790 from the general fund to the information

technology capital account of the capital construction fund;

! \$500,000 from the general fund exempt account of the
general fund to the capital construction fund.

For the 2015-16 fiscal year, the bill transfers \$1 million from the
state historical fund to the capital construction fund for historical
renovations of the state house of representatives' chambers and the state
senate's chambers.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 24-75-302, **amend**
3 (2) introductory portion, (2) (z), (2) (aa), (2.5) introductory portion, (2.5)
4 (h), and (2.5) (i); and **add** (2) (bb), (2.3), and (2.5) (j) as follows:

6 **- calculation - repeal.** (2) ~~On July 1 of each year through July 1, 2014,~~
7 ~~the state treasurer and~~ The controller shall transfer a sum as specified in
8 this subsection (2) ~~out of~~ FROM the general fund ~~and into~~ TO the capital

9 (7) as follows:

12 **restoration fund.** (7) FOR THE FISCAL YEAR COMMENCING JULY 1, 2015,
13 THE STATE TREASURER SHALL TRANSFER ONE MILLION DOLLARS FROM THE
14 STATE HISTORICAL FUND AT THE BEGINNING OF THE FISCAL YEAR TO THE
15 CAPITAL CONSTRUCTION FUND CREATED IN SECTION 24-75-302, C.R.S.,

24 PRESERVATION GRANT PROGRAM ACCOUNT OF THE STATE HISTORICAL
25 FUND AT THE BEGINNING OF THE FISCAL YEAR TO THE CAPITAL
26 CONSTRUCTION FUND CREATED IN SECTION 24-75-302, C.R.S., FOR
27 HISTORIC RENOVATION OF THE STATE HOUSE OF REPRESENTATIVES'

1 CHAMBERS AND THE STATE SENATE'S CHAMBERS.

2 **SECTION 4. Effective date.** (1) Except as otherwise provided
3 in this section, this act takes effect upon passage.

4 (2) Section 2 of this act, adding section 12-47.1-1201 (7),
5 Colorado Revised Statutes, takes effect only if Senate Bill 15-236 does
6 not become law.

7 (3) Section 3 of this act, adding section 12-47.1-1201 (7),
8 Colorado Revised Statutes, takes effect only if Senate Bill 15-236
9 becomes law and takes effect either upon the effective date of this act or
10 Senate Bill 15-236, whichever is later.

11 **SECTION 5. Safety clause.** The general assembly hereby finds,
12 determines, and declares that this act is necessary for the immediate
13 preservation of the public peace, health, and safety.
