A BILL FOR AN ACT

101 **CONCERNING HOME- AND COMMUNITY-BASED SERVICES FOR**
102 **CHILDREN WITH AUTISM, AND, IN CONNECTION THEREWITH,**
103 **MAKING AN APPROPRIATION.**

Bill Summary

Joint Budget Committee. The bill increases the age limit for children receiving services under the autism waiver program from 6 years of age to 8 years of age. The current cap on the annual dollar amount of services that may be provided to a child in the program of \$25,000 is removed and will, instead, be set annually by the medical services board

based upon the general assembly's appropriations.

The bill states that it is the intent of the general assembly that there will be no waiting list for services for eligible children who apply for the waiver program, so the bill removes language about prioritizing placement in the waiver program.

Finally, the bill increases the frequency of program evaluation to an annual evaluation of the effectiveness of the services provided to children pursuant to the waiver program in meeting the goals of the waiver program.

The bill appropriates general fund moneys and moneys from the Colorado autism treatment fund for administration, medical services premiums, and behavioral health capitation payments. In addition, federal funds are expected to be available for the same purposes.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, 25.5-6-802, **amend**
3 (1) (b) as follows:

4 **25.5-6-802. Definitions.** As used in this part 8, unless the context
5 otherwise requires:

6 (1) "Eligible child" means a child who:

7 (b) Is age birth to ~~six~~ EIGHT years; EXCEPT THAT, SO LONG AS A
8 CHILD BEGINS RECEIVING SERVICES PRIOR TO HIS OR HER EIGHTH
9 BIRTHDAY, THE CHILD IS ENTITLED TO CONTINUE RECEIVING SERVICES FOR
10 A TOTAL OF THREE FULL YEARS.

11 **SECTION 2.** In Colorado Revised Statutes, 25.5-6-803, **repeal**
12 (3) (a) as follows:

13 **25.5-6-803. Federal authorization - budget neutrality.**

14 (3) (a) ~~The provision of services pursuant to this part 8 is subject to~~

17 **SECTION 3.** In Colorado Revised Statutes, 25.5-6-804, **amend**
18 (2) and (10); and **repeal** (9) as follows:

26 WHO APPLIES FOR THE WAIVER PROGRAM AND THAT NO ELIGIBLE CHILD IS
27 PLACED ON A WAITING LIST FOR SERVICES.

1 **SECTION 4.** In Colorado Revised Statutes, 25.5-6-806, **amend**
2 (2) (c) (I) introductory portion as follows:

3 **25.5-6-806. Autism waiver - program evaluation.** (2) (c) (I) On
4 or before June 1, 2015, AND EVERY JUNE 1 THEREAFTER, the state
5 department's evaluation shall include an evaluation of eligible children's
6 care plans and evaluations conducted at the beginning and ending of
7 services, as well as ongoing evaluations during the course of services, to
8 determine whether home- and community-based services provided
9 pursuant to this part 8 are effective in meeting the goals of the waiver
10 program, which goals include, but are not limited to:

11 **SECTION 5. Appropriation.** (1) For the 2015-16 state fiscal
12 year, \$5,207,767 is appropriated to the department of health care policy
13 and financing. This appropriation consists of \$367,564 from the general
14 fund that is subject to the "(M)" notation as defined in the general
15 appropriation act for the same fiscal year and \$4,840,203 from the
16 Colorado autism treatment fund created in section 25.5-6-805 (1), C.R.S.
17 To implement this act, the department may use this appropriation for the
18 expansion of the children with autism waiver program as follows:

19 (a) \$57,868 general fund for personal services related to general
20 administration;

21 (b) \$5,005,049, which consists of \$164,846 general fund and
22 \$4,840,203 from the Colorado autism treatment fund created in section
23 25.5-6-805 (1), C.R.S., for medical services premiums; and

24 (c) \$144,850 general fund for behavioral health capitation
25 payments related to behavioral health community programs.

26 (2) For the 2015-16 state fiscal year, the general assembly
27 anticipates that the department of health care policy and financing will

1 receive \$5,408,801 in federal funds for the children with autism waiver.

2 The appropriation in subsection (1) of this section is based on the

3 assumption that the department will receive this amount of federal funds

4 to be used as follows:

5 (a) \$57,868 for personal services related to general administration;

6 (b) \$5,200,111 for medical services premiums; and

7 (c) \$150,822 for behavioral health capitation payments related to

8 behavioral health community programs.

9 **SECTION 6. Effective date.** This act takes effect July 1, 2015.

10 **SECTION 7. Safety clause.** The general assembly hereby finds,

11 determines, and declares that this act is necessary for the immediate

12 preservation of the public peace, health, and safety.
