| 18 | year, \$14,404 is appropriated to the department of human services for use |
| 19 | by the division of youth corrections. This appropriation is from the       |
| 20 | general fund and is based on an assumption that the division will require  |
| 21 | an additional 0.3 FTE. To implement this act, the division may use this    |
| 22 | appropriation as follows:  |
| 23 | (a) \$14,119 for personal services related to administration, which        |
| 24 | amount is based on an assumption that the division will require an         |
| 25 | additional 0.3 FTE; and  |
| 26 | (b) \$285 for operating expenses related to administration.                |
| 27 | SECTION 4. Applicability. This act applies to critical incidents           |
