39 This Report Amends the Rerevised Bill.

40
41 To the President of the Senate and the
42 Speaker of the House of Representatives:
43

1 Your first conference committee appointed on HB15-1013,
 2 concerning the implementation of recommendation number one set forth
 3 in the study of the South Platte river alluvial aquifer prepared by the
 4 Colorado water institute pursuant to House Bill 12-1278, has met and
 5 reports that it has agreed upon the following:
 6

7 1. That the House accede to the Senate amendments made to the
 8 bill, as the amendments appear in the rerevised bill, with the following
 9 changes:
 10

11 Amend rerevised bill, page 5, after line 18 insert:
 12

13 "SECTION 2. In Colorado Revised Statutes, 37-92-305, add (18)
 14 as follows:

15 **37-92-305. Standards with respect to rulings of the referee and**
 16 **decisions of the water judge.** (18) IN THE CASE OF AN AUGMENTATION
 17 PLAN THAT INCLUDES THE CONSTRUCTION OF A RECHARGE STRUCTURE,
 18 THE DIVISION ENGINEER SHALL PROVIDE, AS PART OF THE SUMMARY OF
 19 CONSULTATION REPORT DESCRIBED IN SECTION 37-92-302 (4), AN
 20 ANALYSIS OF POTENTIAL CHANGES IN THE GROUNDWATER LEVELS
 21 DOWNGRAIENT OF THE PROPOSED RECHARGE STRUCTURE RESULTING
 22 FROM THE OPERATION OF THE RECHARGE STRUCTURE, AND THE COURT
 23 AND REFEREE SHALL CONSIDER THE DIVISION ENGINEER'S ANALYSIS.

24 **SECTION 3. Appropriation.** For the 2015-16 state fiscal year,
 25 \$41,959 is appropriated to the department of natural resources for use by
 26 the water resources division. This appropriation is from the general fund
 27 and is based on an assumption that the water resources division will
 28 require an additional 0.5 FTE. To implement this act, the water resources
 29 division may use this appropriation for water administration."
 30

 32

33 2. That, under the authority granted the committee to consider
 34 matters not at issue between the two houses, the following amendments
 35 be recommended:
