**SECTION 2.** In Colorado Revised Statutes, 18-3-505, add (4) (i) as follows:

18-3-505. Human trafficking council - created - duties -The council shall hold its first meeting on or before November 1, 2014, at a time and place to be designated by the executive director of the department of public safety, or by his or her designee. The council shall meet at least four times each year and shall carry out the following duties:

(i) ON OR AFTER JANUARY 1, 2019, PERFORM A POST-ENACTMENT REVIEW OF SECTION 18-7-201.3 AND REPORT ITS FINDINGS TO THE COMMITTEES JUDICIARY OF THE SENATE AND HOUSE OF REPRESENTATIVES, OR ANY SUCCESSOR COMMITTEES.'
