To the President of the Senate and the Speaker of the House of Representatives:

Your first conference committee appointed on HB15-1013, concerning the implementation of recommendation number one set forth in the study of the South Platte river alluvial aquifer prepared by the Colorado water institute pursuant to House Bill 12-1278, has met and reports that it has agreed upon the following:

1. That the House accede to the Senate amendments made to the bill, as the amendments appear in the rerevised bill, with the following changes:

Amend rerevised bill, page 5, after line 18 insert:

"SECTION 2. In Colorado Revised Statutes, 37-92-305, add (18) as follows:

37-92-305. Standards with respect to rulings of the referee and decisions of the water judge. (18) IN THE CASE OF AN AUGMENTATION PLAN THAT INCLUDES THE CONSTRUCTION OF A RECHARGE STRUCTURE, THE DIVISION ENGINEER SHALL PROVIDE, AS PART OF THE SUMMARY OF CONSULTATION REPORT DESCRIBED IN SECTION 37-92-302 (4), AN ANALYSIS OF POTENTIAL CHANGES IN THE GROUNDWATER LEVELS DOWNGRADIENT OF THE PROPOSED RECHARGE STRUCTURE RESULTING FROM THE OPERATION OF THE RECHARGE STRUCTURE, AND THE COURT AND REFEREE SHALL CONSIDER THE DIVISION ENGINEER'S ANALYSIS.

SECTION 3. Appropriation. For the 2015-16 state fiscal year, \$41,959 is appropriated to the department of natural resources for use by the water resources division. This appropriation is from the general fund and is based on an assumption that the water resources division will require an additional 0.5 FTE. To implement this act, the water resources division may use this appropriation for water administration.".

Renumber succeeding section accordingly.

2. That, under the authority granted the committee to consider matters not at issue between the two houses, the following amendments be recommended:

Amend rerevised bill, page 5, strike line 20 and substitute:

"SECTION 3. Act subject to petition - effective date - applicability. (1) This act".

Page 6, after line 2 insert:

"(2) This act applies to water court applications filed on or after the effective date.".

WHEREAS, Since 2013 and the inception of negotiations with Iran over its plans for developing nuclear weapons, the United States government has promised the American people that the negotiations with Iran has as the primary goal the prevention of Iran from continuing to develop its capacity for producing nuclear weapons; and

WHEREAS, The Prime Minister of Israel, Benjamin Netanyahu, has stated that the proposed "Framework" agreement poses a clear and present danger to Israel's survival if we accept and allow Iran's development of a nuclear weapons capability; and

WHEREAS, Members of both major political parties in Congress have voiced serious concerns over the threat of nuclear proliferation in Iran; and

WHEREAS, The people of Colorado are united in their concern over the possession of nuclear weapons by any nation that openly supports and clandestinely finances terrorist organizations that conduct violent acts against the people of the United States, the people of Israel, and other peoples and nations; and

WHEREAS, The citizens of Colorado and their children, grandchildren, and future generations have a vital, existential stake in preventing terrorist organizations and rogue nations that support terrorism from obtaining nuclear weapons; now, therefore,".
