Amend engrossed bill, page 4, strike lines 8 through 16 and substitute:

"(g) In Surplus Trading Co. v. Cook, 281 U.S. 647, 650 (1930), the United States Supreme Court stated that "[i]t is not unusual for the United States to own within a State lands which are set apart and used for public purposes. Such ownership and use without more do not withdraw the lands from the jurisdiction of the State. On the contrary, the lands remain part of her territory and within the operation of her laws, save that the latter cannot affect the title of the United States or embarrass it in using the lands or interfere with its right of disposal." In Kleppe v. New Mexico, 426 U.S. 529, 543 (1976), the United States Supreme Court stated that a state is free to enforce its criminal and civil laws on public lands over which the federal government does not assert exclusive jurisdiction. Further, the Federal Land Policy and Management Act enacted by Congress in 1976 states in Section 701 (g) (6) that "[n]othing in this Act shall be construed...as a limitation upon any State criminal statute or upon the police power of the respective States...or as depriving any State or political subdivision thereof of any right it may have to exercise civil and criminal jurisdiction on the natural resource lands...";".
