**A BILL FOR AN ACT**

101      **CONCERNING THE IMMEDIATE REESTABLISHMENT OF THE VOLUNTARY**  
102            **CONTRIBUTIONS EXCLUDED FROM THE 2015 COLORADO INCOME**  
103            **TAX RETURN FORM FOR NOT RECEIVING THE REQUISITE**  
104            **MINIMUM DOLLAR AMOUNT OF CONTRIBUTIONS BY THE**  
105            **STATUTORY DEADLINE, AND, IN CONNECTION THEREWITH,**  
106            **EXPANDING THE NUMBER OF VOLUNTARY CONTRIBUTIONS THAT**  
107            **MAY APPEAR ON THE INCOME TAX RETURN FORM AND**  
108            **LOWERING THE MINIMUM AMOUNT OF DONATIONS THAT MUST**  
109            **BE RECEIVED BY EVERY FUND APPEARING ON THE FORM.**

Generally, each fund in the voluntary contribution program (commonly referred to as the "check-off" program) must receive a minimum amount of \$75,000 in contributions over a 9-month period in order to retain its place on the income tax return form (form). In 2015, the following 6 funds failed to meet that requisite minimum and were therefore excluded from the form:

- ! The Colorado healthy rivers fund voluntary contribution;
- ! The Alzheimer's Association fund voluntary contribution;
- ! The Colorado multiple sclerosis fund voluntary contribution;
- ! The Colorado cancer fund voluntary contribution;
- ! The Make-A-Wish Foundation of Colorado fund voluntary contribution; and
- ! The unwanted horse fund voluntary contribution.

In order to immediately reestablish the above funds, the bill expands from 15 to 20 the statutory maximum number of funds that may appear on the form at any one time. Each reestablished fund sunsets in 5 years, subject to the minimum dollar amount of contributions that all check-offs are required to receive.

The bill lowers, to \$50,000, the minimum dollar amount that every fund must receive.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2           **SECTION 1.** In Colorado Revised Statutes, 39-22-1001, **amend**  
3 (5) introductory portion, (5) (a), and (7) as follows:

4           **39-22-1001. Limitation on the duration of voluntary**  
5 **contribution programs - queue - notice - reestablishment of certain**  
6 **programs - repeal.** (5) ~~For income tax years commencing on or after~~  
7 ~~January 1, 2005,~~ Every voluntary contribution established in this article  
8 ~~shall~~ MUST receive a minimum dollar amount of contributions in each  
9 income tax year as follows:

10           (a) Except as otherwise provided in paragraphs (b) and (c) of this  
11 subsection (5), ~~for the period January 1, 2005, through September 30,~~

1     ~~2005, and~~ for each PERIOD RUNNING FROM January 1 through September  
2     30, ~~thereafter~~, if the amount designated on Colorado income tax returns  
3     as contributed ~~under the provisions of~~ TO any voluntary contribution  
4     established in this article does not equal or exceed ~~seventy-five~~ FIFTY  
5     thousand dollars according to the records of the department of revenue,  
6     then ~~any~~ such voluntary contribution ~~shall~~ IS no longer ~~be~~ effective and  
7     shall not be reflected on the Colorado income tax returns made for any  
8     subsequent income tax year, ~~regardless of whether~~ UNLESS the voluntary  
9     contribution is reestablished by the general assembly pursuant to  
10    subsection (1) of this section.

11           (7) (a) No more than ~~fifteen~~ TWENTY voluntary contributions ~~shall~~  
12    ARE PERMITTED TO appear on the Colorado income tax return form in any  
13    income tax year. If the general assembly, acting by bill in any year,  
14    requires more voluntary contributions to appear on the income tax return  
15    form than there are lines available on the form, an existing voluntary  
16    contribution that is renewed or continued ~~shall take~~ TAKES precedence  
17    and MUST be placed on the form over a voluntary contribution that does  
18    not appear on the form. ~~and is not being renewed or continued~~. Any  
19    voluntary contribution that does not appear on the form and is not being  
20    renewed or continued but does not take effect pursuant to this subsection  
21    (7) ~~shall~~ MUST be placed in the queue created by subsection (8) of this  
22    section and ~~shall only become~~ BECOMES effective in any year in which  
23    there is a line available on the income tax return form, as specified in  
24    subsection (8) of this section.

25           (b) (I) NOTWITHSTANDING ANY PROVISION OF THIS SECTION TO  
26    THE CONTRARY, IN ORDER TO EFFECT HOUSE BILL 16-1297, ENACTED IN  
27    2016, THE DEPARTMENT OF REVENUE SHALL INCLUDE THE FOLLOWING

1 VOLUNTARY CONTRIBUTIONS ON THE COLORADO INCOME TAX RETURN  
2 FORM FOR THE 2016 TAX YEAR:

3 (A) THE COLORADO HEALTHY RIVERS FUND VOLUNTARY  
4 CONTRIBUTION, CREATED IN PART 24 OF THIS ARTICLE;

5 (B) THE ALZHEIMER'S ASSOCIATION FUND VOLUNTARY  
6 CONTRIBUTION, CREATED IN PART 29 OF THIS ARTICLE;

7 (C) THE COLORADO MULTIPLE SCLEROSIS FUND VOLUNTARY  
8 CONTRIBUTION, CREATED IN PART 32 OF THIS ARTICLE;

9 (D) THE COLORADO CANCER FUND VOLUNTARY CONTRIBUTION,  
10 CREATED IN PART 33 OF THIS ARTICLE;

11 (E) THE MAKE-A-WISH FOUNDATION OF COLORADO FUND  
12 VOLUNTARY CONTRIBUTION, CREATED IN PART 36 OF THIS ARTICLE; AND

13 (F) THE UNWANTED HORSE FUND VOLUNTARY CONTRIBUTION,  
14 CREATED IN PART 38 OF THIS ARTICLE.

15 (II) THE VOLUNTARY CONTRIBUTIONS DESCRIBED IN  
16 SUBPARAGRAPH (I) OF THIS PARAGRAPH (b) ARE SUBJECT TO THE MINIMUM  
17 CONTRIBUTION REQUIREMENT SET FORTH IN PARAGRAPH (a) OF  
18 SUBSECTION (5) OF THIS SECTION.

19 (III) THIS PARAGRAPH (b) IS REPEALED, EFFECTIVE JULY 1, 2017.

20 **SECTION 2.** In Colorado Revised Statutes, **amend** 39-22-2402  
21 as follows:

22 **39-22-2402. Voluntary contribution designation - procedure.**

23 For income tax years commencing on or after ~~January 1, 2008~~ JANUARY  
24 1, 2016, but prior to January 1, 2021, the Colorado state individual  
25 income tax return form ~~shall~~ MUST contain a line whereby each individual  
26 taxpayer may designate the amount of the contribution, if any, the  
27 individual wishes to make to the Colorado healthy rivers fund created in

1 section 39-22-2403.

2 **SECTION 3.** In Colorado Revised Statutes, **add** 39-22-2404 as  
3 follows:

4 **39-22-2404. Repeal of part.** THIS PART 24 IS REPEALED,  
5 EFFECTIVE JANUARY 1, 2022, UNLESS THE VOLUNTARY CONTRIBUTION TO  
6 THE COLORADO HEALTHY RIVERS FUND CREATED IN SECTION 39-22-2403  
7 IS CONTINUED OR REESTABLISHED BY THE GENERAL ASSEMBLY ACTING BY  
8 BILL PRIOR TO THAT DATE.

9 **SECTION 4.** In Colorado Revised Statutes, **amend** 39-22-2901  
10 as follows:

11 **39-22-2901. Voluntary contribution designation - procedure.**  
12 For income tax years that commence on or after ~~January 1, 2011~~  
13 JANUARY 1, 2016, but before ~~January 1, 2016~~ JANUARY 1, 2021, the  
14 Colorado state individual income tax return form ~~shall~~ MUST contain a  
15 line whereby each individual taxpayer may designate the amount of the  
16 contribution, if any, the individual wishes to make to the Alzheimer's  
17 Association fund created in section 39-22-2902.

18 **SECTION 5.** In Colorado Revised Statutes, **amend** 39-22-2903  
19 as follows:

20 **39-22-2903. Repeal of part.** This part 29 is repealed, effective  
21 ~~January 1, 2017~~ JANUARY 1, 2022, unless the voluntary contribution to the  
22 Alzheimer's Association fund established by section 39-22-2902 is  
23 continued or reestablished by the general assembly acting by bill prior to  
24 ~~said~~ THAT date.

25 **SECTION 6.** In Colorado Revised Statutes, **amend** 39-22-3202  
26 as follows:

27 **39-22-3202. Voluntary contribution designation - procedure.**

1 For income tax years commencing on or after ~~January 1, 2012~~ JANUARY  
2 1, 2016, but prior to ~~January 1, 2022~~ JANUARY 1, 2021, the Colorado state  
3 individual income tax return form ~~shall~~ MUST contain a line whereby each  
4 individual taxpayer may designate the amount of the contribution, if any,  
5 the individual wishes to make to the Colorado multiple sclerosis fund  
6 created in section 39-22-3203.

7 **SECTION 7.** In Colorado Revised Statutes, **amend** 39-22-3204  
8 as follows:

9 **39-22-3204. Repeal of part.** This part 32 is repealed, effective  
10 ~~January 1, 2023~~ JANUARY 1, 2022, unless the voluntary contribution to the  
11 Colorado multiple sclerosis fund established by section 39-22-3203 is  
12 continued or reestablished by the general assembly acting by bill prior to  
13 that date.

14 **SECTION 8.** In Colorado Revised Statutes, **amend** 39-22-3302  
15 as follows:

16 **39-22-3302. Voluntary contribution designation - procedure.**  
17 For income tax years commencing on or after ~~January 1, 2012~~ JANUARY  
18 1, 2016, but prior to ~~January 1, 2017~~ JANUARY 1, 2021, the Colorado state  
19 individual income tax return form ~~shall~~ MUST contain a line whereby each  
20 individual taxpayer may designate the amount of the contribution, if any,  
21 the individual wishes to make to the Colorado cancer fund created in  
22 section 39-22-3303.

23 **SECTION 9.** In Colorado Revised Statutes, **amend** 39-22-3304  
24 as follows:

25 **39-22-3304. Repeal of part.** This part 33 is repealed, effective  
26 ~~January 1, 2018~~ JANUARY 1, 2022, unless the voluntary contribution to the  
27 Colorado cancer fund established by section 39-22-3303 is continued or

1 reestablished by the general assembly acting by bill prior to said date.

2 **SECTION 10.** In Colorado Revised Statutes, **amend** 39-22-3602  
3 as follows:

4 **39-22-3602. Voluntary contribution designation - procedure.**

5 For income tax years commencing on or after ~~January 1, 2012~~ JANUARY  
6 1, 2016, but prior to ~~January 1, 2017~~ JANUARY 1, 2021, the Colorado state  
7 individual income tax return form shall contain a line whereby each  
8 individual taxpayer may designate the amount of the contribution, if any,  
9 the individual wishes to make to the Make-A-Wish Foundation of  
10 Colorado fund created in section 39-22-3603 (1).

11 **SECTION 11.** In Colorado Revised Statutes, **amend** 39-22-3604  
12 as follows:

13 **39-22-3604. Repeal of part.** This part 36 is repealed, effective  
14 ~~January 1, 2018~~ JANUARY 1, 2022, unless the voluntary contribution to the  
15 Make-A-Wish Foundation of Colorado fund established by section  
16 39-22-3602 is continued or reestablished by the general assembly acting  
17 by bill prior to that date.

18 **SECTION 12.** In Colorado Revised Statutes, **amend** 39-22-3802  
19 as follows:

20 **39-22-3802. Voluntary contribution designation - procedure.**

21 For income tax years commencing on or after ~~January 1, 2013~~ JANUARY  
22 1, 2016, but prior to ~~January 1, 2018~~ JANUARY 1, 2021, the Colorado state  
23 individual income tax return form must contain a line whereby each  
24 individual taxpayer may designate the amount of the contribution, if any,  
25 the individual wishes to make to the unwanted horse fund created in  
26 section 39-22-3803 (1).

27 **SECTION 13.** In Colorado Revised Statutes, **amend** 39-22-3804

1 as follows:

2 **39-22-3804. Repeal of part.** This part 38 is repealed, effective  
3 ~~January 1, 2019~~ JANUARY 1, 2022, unless the voluntary contribution to the  
4 unwanted horse fund established by this part 38 is continued or  
5 reestablished by the general assembly acting by bill prior to that date.

6 **SECTION 14. Safety clause.** The general assembly hereby finds,  
7 determines, and declares that this act is necessary for the immediate  
8 preservation of the public peace, health, and safety.
