SB16-169 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 3 Page 5, line 5, after "TO" insert "AN EMERGENCY MEDICAL SERVICES
- 4 FACILITY OR".
- 5 Page 5, strike line 17 and substitute "~~director for a~~ TAKEN TO".
- 6 Page 5, line 20, after "TO" insert "AN EMERGENCY MEDICAL SERVICES
- 7 FACILITY OR".
- 8 Page 6, line 25, strike "SEVENTY-TWO" and substitute "TWENTY-FOUR".

- 15 Page 9, line 27, before "shall" insert "OR EMERGENCY MEDICAL SERVICES

5 **27-60-103. Behavioral health crisis response system - services**

7 (6.5) ON OR BEFORE JANUARY 31, 2017, THE STATE DEPARTMENT SHALL
8 PRESENT TO THE JOINT JUDICIARY COMMITTEE AND THE JOINT HEALTH AND
9 HUMAN SERVICES COMMITTEE A NEEDS ANALYSIS AND BUDGET REQUEST
10 FOR EMERGENCY MENTAL HEALTH TREATMENT NEEDS THROUGHOUT
11 COLORADO AS PART OF ITS "STATE MEASUREMENT FOR ACCOUNTABLE,
12 RESPONSIVE, AND TRANSPARENT (SMART) GOVERNMENT ACT" HEARING
13 REQUIRED BY SECTION 2-7-203, C.R.S."
