<u>HB16-1358</u> be amended as follows, and as so amended, be referred to the Committee on <u>Appropriations</u> with favorable recommendation:

1 Amend printed bill, page 2, strike lines 2 through 22 and substitute:

2 "SECTION 1. In Colorado Revised Statutes, 27-81-104, add (2)
3 as follows:

27-81-104. Duties of the unit - review - patient privacy repeal. (2) IN ADDITION TO THE DUTIES DESCRIBED IN SUBSECTION (1) OF
THIS SECTION, THE UNIT HAS THE FOLLOWING DUTIES RELATING TO THE
PROTECTION OF PATIENTS' PERSONAL IDENTIFYING INFORMATION:

8 (a) (I) ON OR BEFORE DECEMBER 1, 2016, THE UNIT SHALL 9 COMPLETE A REVIEW OF ITS POLICIES AND PROCEDURES, OTHER STATES' 10 POLICIES AND PROCEDURES, AND FEDERAL REQUIREMENTS RELATING TO 11 THE COLLECTION AND PROTECTION OF DATA CONTAINING PATIENTS' 12 PERSONAL IDENTIFYING INFORMATION. THE UNIT SHALL USE THE REVIEW 13 TO IDENTIFY ANY CHANGES THAT ARE NECESSARY OR THAT WOULD 14 IMPROVE THE UNIT'S OWN POLICIES AND PROCEDURES, AND THE UNIT 15 SHALL IMPLEMENT SUCH CHANGES AS SOON AS PRACTICABLE UPON THE 16 COMPLETION OF THE REVIEW.

17 (II) THIS PARAGRAPH (a) IS REPEALED, EFFECTIVE DECEMBER 1,2018.

(b) ON AND AFTER DECEMBER 1, 2016, EXCEPT AS REQUIRED BY
SECTION 27-80-210, OR FOR THE PURPOSE OF MONITORING THE PROBATION
OF A PERSON CONVICTED OF A DUI OFFENSE UNDER SECTION 42-2-126 OR
42-4-1301, C.R.S., OR AS MAY BE REQUIRED BY FEDERAL LAW OR ANY
STATE OR FEDERAL PUBLIC-FUNDED SERVICES, THE UNIT SHALL NOT

COLLECT ANY PERSONAL IDENTIFYING INFORMATION FROM A PATIENT
