# A BILL FOR AN ACT CONCERNING THE CREATION OF A PILOT PROGRAM FOR INCLUSIVE HIGHER EDUCATION FOR PERSONS WITH INTELLECTUAL AND DEVELOPMENTAL DISABILITIES, AND, IN CONNECTION

104 THEREWITH, MAKING AN APPROPRIATION.

# **Bill Summary**

The bill creates the pilot program for inclusive higher education for students with intellectual and developmental disabilities (pilot program) and identifies pilot sites at institutions of higher education in the HOUSE 2nd Reading Unamended May 9, 2016

state (institutions), including 2 4-year institutions and one community college.

The bill requires the department of higher education (department), the institutions participating in the pilot program, JFK Partners, defined in the bill as a program of the university of Colorado medical school, and IN!, defined in the bill as a stakeholder group supporting inclusive higher education, to work together to develop pilot programs at the pilot sites.

The bill specifies the minimum requirements for each inclusive higher education pilot program, including, among other requirements, the development of programming for students that allows a student to take two on-campus undergraduate courses each semester in the student's chosen area of interest and a course specific to inclusive higher education, and to earn a certificate from the institution at the completion of the program. In addition, the inclusive higher education pilot programs shall integrate students socially and academically to the greatest extent possible, and shall be outcome-focused in preparing the student for gainful employment in the community.

The bill requires JFK Partners to complete an annual formative evaluation of each pilot program and the department to report to the general assembly annually concerning the implementation of inclusive higher education, as well as the results of the JFK Partners evaluation.

The bill requires the department to enter into fee-for-service contracts with the governing boards of the institutions, and recognizes that fee-for-service contracts for inclusive higher education programs are not included in certain defined terms for purposes of calculating total appropriations in the college opportunity fund program or determining appropriations for student financial assistance.

The pilot program is repealed July 1, 2021.

The bill includes transfers of money from the intellectual and developmental disabilities services cash fund in 2016 and 2017 and an appropriation clause.

Be it enacted by the General Assembly of the State of Colorado:
