A BILL FOR AN ACT

101 CONCERNING THE ABILITY OF A LICENSED SPIRITUOUS LIQUORS
102 MANUFACTURER TO SELF-DISTRIBUTE A SPECIFIED AMOUNT OF
103 ITS OWN MANUFACTURED PRODUCT PER CALENDAR YEAR
104 WITHOUT PROCURING A WHOLESALER'S LICENSE.

Bill Summary

The bill allows a licensed spirituous liquors manufacturer to self-distribute up to 9,000 liters per spirituous liquor product of its own manufacture in a calendar year without obtaining a wholesaler's license.

1 *Be it enacted by the General Assembly of the State of Colorado:*

2 **SECTION 1.** In Colorado Revised Statutes, **amend** 12-47-107 as
3 follows:

4 **12-47-107. Permitted acts.** (1) Any person who has an interest
5 in a liquor license may also be listed as an officer or director on a license
6 owned by a municipality or governmental entity if such person does not
7 individually manage or receive any direct financial benefit from the
8 operation of such license.

9 (2) NOTWITHSTANDING ANY PROVISION OF THIS ARTICLE TO THE
10 CONTRARY, A MANUFACTURER LICENSED UNDER SECTION 12-47-402 TO
11 PRODUCE, MANUFACTURE, OR RECTIFY SPIRITUOUS LIQUORS MAY SELL UP
12 TO NINE THOUSAND LITERS PER SPIRITUOUS LIQUOR OF ITS OWN
13 MANUFACTURE PER CALENDAR YEAR AT WHOLESALE TO LICENSED
14 RETAILERS WITHOUT PROCURING A SEPARATE WHOLESALER'S LICENSE.

15 **SECTION 2. Safety clause.** The general assembly hereby finds,
16 determines, and declares that this act is necessary for the immediate
17 preservation of the public peace, health, and safety.
