101 **CONCERNING AWARENESS DAY FOR INDIVIDUALS WITH INTELLECTUAL**

1 WHEREAS, For over 50 years, Colorado's community-based
2 services system has led the way for individuals with intellectual and
3 developmental disabilities to receive services and supports that afford
4 them greater independence and community interaction; and

5 WHEREAS, Colorado's community system for individuals with
6 intellectual and developmental disabilities has a long, proud history of
7 enabling individuals to move from large, institutional services to smaller,
8 community-based integrated services that offer personalized assistance
9 and support; and

1 intellectual and developmental disabilities helps individuals obtain
2 meaningful employment in a variety of settings, allowing them to work
3 and build relationships within their communities; and

4 WHEREAS, Coloradans with intellectual and developmental
5 disabilities in every county across the state are able to live, learn, play,
6 and work in their communities with the dignity, choices, opportunities,
7 and responsibilities afforded to all citizens due to the services and
8 supports provided by local community-centered boards and
9 program-approved service agencies; and

10 WHEREAS, There is significant demand across Colorado for
11 services and supports for individuals with intellectual and developmental
12 disabilities, and waiting lists for services are growing; and

13 WHEREAS, Today, more than 15,000 Coloradans with intellectual
14 and developmental disabilities receive high-quality services and supports
15 through community-centered boards and program-approved service
16 agencies; now, therefore,

17 *Be It Resolved by the Senate of the Seventieth General Assembly*
18 *of the State of Colorado, the House of Representatives concurring herein:*

19 That we, the members of the Colorado General Assembly,
20 proclaim February 17, 2016, to be Awareness Day for Individuals with
21 Intellectual and Developmental Disabilities in the state of Colorado.

22 *Be It Further Resolved,* That copies of this Joint Resolution be sent
23 to community-centered boards and organizations that provide services
24 and supports to adults and children with intellectual and developmental
25 disabilities and their families throughout Colorado.
