A BILL FOR AN ACT CONCERNING THE FUNDING OF COLORADO WATER CONSERVATION BOARD PROJECTS, AND, IN CONNECTION THEREWITH, MAKING

103 APPROPRIATIONS.

Bill Summary

(Note: This summary applies to this bill as introduced and does not reflect any amendments that may be subsequently adopted. If this bill passes third reading in the house of introduction, a bill summary that applies to the reengrossed version of this bill will be available at http://www.leg.state.co.us/billsummaries.)

The bill appropriates the following amounts from the Colorado water conservation board (CWCB) construction fund to the CWCB or the division of water resources for the following projects:

! \$380,000 for continuation of the satellite monitoring system maintenance (**section 1** of the bill);

- ! \$500,000 for continuation of the Colorado floodplain map modernization program (section 2);
- ! \$1,500,000 for continuation of the watershed restoration program (section 3);
- ! \$175,000 for continuation of the weather modification program (section 4);
- ! \$150,000 for the board to support the Colorado Mesonet, a spatially coherent network of weather stations reporting in near real-time via major data portals (section 5);
- ! \$300,000 for the water forecasting partnership project (section 6);
- ! \$2,500,000 for a Bear Creek reservoir reallocation study (section 7);
- ! \$200,000 for an underground storage study (**section 8**);
- ! \$1,000,000 for continuation of the statewide water supply initiative (section 9); and
- ! \$200,000 for continuation of the Windy Gap reservoir bypass channel project (**section 10**).

The bill directs the state treasurer to transfer the following amounts from the CWCB construction fund:

- ! Up to \$500,000 to the flood and drought response fund (section 11); and
- ! \$600,000 to the litigation fund (section 12).

Current law prevents the CWCB from participating in domestic water treatment and distribution systems projects; **section 13** changes this prohibition to water treatment facilities.

Section 14 gives the CWCB a variety of powers to fully utilize the state's water allocation in the Animas-La Plata project, directs the state treasurer to credit money received pursuant to the exercise of those powers to the CWCB construction fund, and continuously appropriates this money to the board for this purpose.

Section 15 transfers the following amounts from the severance tax perpetual base fund to the CWCB construction fund:

- ! \$200,000 for the Windy Gap reservoir bypass channel project;
- ! \$1,500,000 for the watershed restoration program, \$2,500,000 for the Bear Creek reservoir reallocation study, and \$1,000,000 for the statewide water supply initiative; and
- ! On each July 1, \$5,000,000 to fund studies, programs, or projects to implement the state water plan.

To implement this section, the Colorado water conservation board may use this appropriation to continue to assist with the preparation of revised and improved floodplain studies and maps for communities throughout Colorado and participate in federally sponsored floodplain map modernization activities.

(2) The money appropriated in subsection (1) of this section remains available for the designated purposes until it is fully expended.

To implement this section, the Colorado water conservation board may use this appropriation to continue to assist water conservation districts, water conservancy districts, and other water providers and their fiscal agents with the development of cloud seeding programs that provide benefits to recreation, streams, and reservoirs through snowpack enhancement.
